INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF SCEPTRE CONSULTANTS LIMITED

Opinion

We have audited the financial statements of Sceptre Consultants Limited ("the Company") for the year ended 31 December 2018, which comprise the Statement of Comprehensive Income, Balance Sheet and related notes, including the accounting policies in note 1.

In our opinion the financial statements:

- give a true and fair view of the state of the Company's affairs as at 31 December 2018 and of its profit for the year then ended;
- have been properly prepared in accordance with UK accounting standards applicable to smaller entities, including Section 1A of FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the Company in accordance with, UK ethical requirements including the FRC Ethical Standard, and the provisions available for small entities, in the circumstances set out in note 1 to the financial statements. Notes to the Financial Statements for the Year Ended 31 December 2018

1. ACCOUNTING POLICIES

The principal activity of the Company is that of the provision of administration services. The Company was incorporated in the United Kingdom on 23 December 1983. The registered office is 5th Floor, 86 Jermyn Street, London, SW1Y 6AW.

Basis of preparing the financial statements

These financial statements and related notes have been prepared in accordance with UK Accounting Standards including FRS 102: The Financial Reporting Standard applicable in the UK and Republic of Ireland, and applicable law. In addition, exemptions available to small companies under Section 1A of FRS 102 have been taken. The financial statements have been prepared on the historical cost basis.

The financial statements are presented in Sterling (\mathfrak{L}) , which is the company's functional currency, and have been rounded to the nearest pound.

The Company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland":

- the requirements of Section 7 Statement of Cash Flows;
- the requirements of Section 33 Related Party Disclosures paragraph 33.7.

The Company continued to trade in the current year and the Directors expect it to continue at this level during 2018 and have no intention to cease trading in future. The Company's immediate parent, SMP Partners Limited, undertakes to cover any liabilities as and when they fall due. Therefore, these financial statements have been prepared on the going concern basis.

Significant accounting policies are as follows:

Turnover

Turnover represents fees earned during the year, excluding Value Added Tax and after deduction of credits given, and is accounted for on an accruals basis.

Trade debtors

Trade debtors are held at fair value of the consideration received and are subject to impairment review on a quarterly basis.

Trade creditors

Trade creditors are held at amortised cost.

Expenses

Expenses are recognised on an accruals basis.

Related party exemption

The Company has taken advantage of the exemption, under the terms of section 1A of FRS 102, not to disclose related party transactions with wholly owned subsidiaries within the group. Certain Directors and Officers of the Company act as Directors and Officers of client corporate entities. They do not derive any benefit from this and all fees and other income attributed to this activity are accounted for in the accounts of the Company.

Notes to the Financial Statements - continued for the Year Ended 31 December 2018

1. ACCOUNTING POLICIES (continued)

Critical accounting judgements and estimation uncertainty

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. There were no significant accounting assumptions or estimates in the financial statements other than those included within the doubtful debts provision and estimated as management's best estimate of the recoverability of specific items.

2. STAFF COSTS

There were no staff costs for the year ended 31 December 2018 (2017: £nil).

3. OPERATING PROFIT

Auditors' remuneration for the year was £1,600 (2017: £nil as the cost was borne by another group company) and there is no Directors' remuneration payable by the Company.
