Accounting policies

The principal accounting policies adopted in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Basis of preparation

Under European Union (EU) law (IAS Regulation EC 1606/2002), the Accounts for the year ended 31 December 2006 of the company's parent undertaking, Newcastle Building Society, were required to be prepared in accordance with International Financial Reporting Standards ('IFRSs') as adopted for use in the EU. Consequently, for the first time, these financial statements have also been prepared in accordance with IFRSs and with those parts of the Companies Act 1985 applicable to companies reporting under IFRS.

The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Although these estimates are based on management's best knowledge of the amount, event or actions, actual results ultimately may differ from those estimates.

Cash flow statement

The company is exempt from the requirement to prepare a cash flow statement under IFRS 7 as it is a wholly owned subsidiary and its parent undertaking's annual report is publicly available.
