THIS DEED is dated H day of March 20145

- (1) THE CHANNEL TUNNEL GROUP LIMITED, a limited liability company incorporated under the laws of England and Wales with registered number 01811435 and with its registered offices situated at UK Terminal, Ashford Road, Folkestone, Kent CTI8 8XX) ("CTG");
- (2) FRANCE MANCHE S.A. a limited liability company incorporated under the laws of France with registered number 333 286 714 RCS Paris, with a registered number in the UK of FC013582 and with its registered offices situated at 19 Boulevard Malesherbes, 75008 Paris, France ("France-Manche", and together with CTG, each a "Company" and together the "Companies"); and
- (3) **DEUTSCHE TRUSTEE COMPANY LIMITED**, a private limited company incorporated under the laws of England and Wales with registered number 00338230 and with its registered offices situated at Winchester House, 1 Great Winchester Street, London EC2N 2DB (the "Security Trustee")

BACKGROUND

It is intended that this document take effect as a deed notwithstanding the fact that a party may only execute this document under hand.

IT IS AGREED as follows:

1. Definitions

In this Deed:

"Mortgaged Property":

- (a) the property specified in Schedule 1 (Details of Mortgaged Property); and
- (b) any buildings, fixtures, fittings, fixed plant or machinery from time to time situated on or forming part of such property,

and includes all Related Rights.

"Related Rights": in relation to any asset:

- (a) the proceeds of sale of any part of that asset;
- (b) all rights under any licence, agreement for sale or agreement for lease in respect of that asset;
- (c) all rights powers benefits claims contracts warranties remedies security guarantees indemnities or covenants for title in respect of that asset; and
- (d) any monies and proceeds paid or payable in respect of that asset.

2. Fixed security

Each Company charges with full title guarantee in favour of the Security Trustee with the payment and discharge of the Secured Obligations, by way of first legal mortgage the Mortgaged Property.

3. Implied covenants for title

- (a) The covenants set out in Sections 3(1), 3(2) and 6(2) of the Law of Property (Miscellaneous Provisions) Act 1994 will not extend to Clause & (Fixed Charges, Security)
- (b) It shall be implied in respect of Clause & (Fixed Charges: Assignments and Floating Charges) that each Company is disposing of the Mortgaged Property free from all charges and incumbrances (whether monetary or not) and from all other rights exercisable by third parties (including liabilities imposed and rights conferred by or under any enactment).

4. Application to the Land Registry

Each Company consents to an application being made to the Land Registry to enter the following restriction in the Proprietorship register of any property which is or is required to be registered forming part of the Mortgaged Property:

"No disposition (in particular no transfer, charge, mortgage or lease) of the registered estate by the proprietor of the registered estate, or by the proprietor of any future registered charge, is to be completed by registration without a written consent signed by the proprietor for the time being of the charge dated [] in favour of Deutsche Trustee Company Limited referred to in the Charges Register."

5. Release of Security

Redemption of Security

Upon the Secured Obligations being discharged in full and none of the Secured Parties being under any further actual or contingent obligation to make advances or provide other financial accommodation to the Companies or any other person under any agreement between the Security Trustee and the Companies, the Security Trustee shall, at the request and cost of the Companies, release and cancel the security constituted by this Mortgage and procure the reassignment to the Companies of the property and assets assigned to the Security Trustee pursuant to this Mortgage, in each case subject to Clause 5.2 (Avoidance of Payments) and without recourse to, or any representation or warranty by, the Security Trustee or any of its nominees.

Avoidance of Payments

5.2 If the Security Trustee considers that any amount paid or credited to it is capable of being avoided or reduced by virtue of any bankruptcy, insolvency, liquidation or similar laws, the liability of each Company under this Mortgage and the security constituted hereby shall continue and such amount shall not be considered to have been irrevocably paid.

6. Third Party Rights

A person who is not a party to this Deed has no rights under the Contracts (Rights of Third Parties) Act 1999 to enforce or to enjoy the benefit of any term of this Deed.

7. Governing Law

This Deed is governed by English law.

8. Counterparts

This Deed may be executed in any number of counterparts, each of which shall be deemed an original and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed. Any party may enter into this Mortgage by signing any such counterpart.


