The Board have pleasure in presenting their annual report together with audited financial statements for the year ended 30th September 2001.

OBJECTS

The objects of the charity are to relieve the poverty, hardship and distress caused by homelessness and bad housing.

In pursuit of these objectives the Board of Trustees in 2000/2001 agreed the following aims:

To bring about long term changes at the national and local level to policies, practices and legislation that will reduce homelessness and housing need.

To increase opportunities for people in housing need to have a greater say over their own lives.

To contribute practically to the elimination of homelessness and poor housing through housing advice, training, education and information with the aim of providing sustainable solutions for people in housing need.

ORGANISATIONAL STRUCTURE

Shelter Cymru is organised into two regional areas (north and south Wales) each with a Regional Director with responsibilities for:

Housing Advice Services; Campaigning; Training Services; Fund-raising; Finance.

The entire organisation and Regional Directors are under the overall responsibility and leadership of the Director (Chief Executive) of Shelter Cymru.

REVIEW OF ACTIVITY

Housing Advice Services

During the year under review Shelter Cymru's Housing Advice Service was able to assist more people than ever before facing housing problems, and made further progress in its aim of providing quality, accessible housing advice to anyone in housing need in Wales.

The continued development of the service over recent years accelerated further during the year and we were able to support or launch housing advice provision in 21 local authority areas operating from 63 venues. The Community Housing Advice Service, combined with Shelterline dealt with over 10,000 housing problems during the twelve month period. In over 7 out of 10 relevant cases the service was able to prevent homelessness. User feedback during the year recorded 96% satisfaction with our services.

Shelter Cymru's importance in being the only major all-Wales provider of independent housing advice was confirmed in the Welsh Assembly Government *Audit of Housing Advice*, and continued support from the Legal Services Commission for relevant service development. Legal Service Commission audits continued to confirm the quality of the service provided.

In addition to housing advice provision we were also able to launch, with the support of the Welsh Assembly Government, new innovative support services for social housing tenants facing homelessness and people living in hostels attempting to move into longer term accommodation.

Also in partnership with Bridgend County Borough Council, and supported by the Welsh Assembly Government, we launched an innovative pilot project looking at the impact of Personal Housing Plans on reducing repeat homelessness and encouraging greater choice and involvement of people in their housing outcomes.

We were also able to maintain our advice services for users of the Probation Services in north and south Wales and specialised housing benefit advice services working in partnership with Registered Social Landlords.

The year also saw the foundations laid for further important housing advice developments that will increase our capacity to prevent homelessness and improve housing conditions for people in housing need. Most significantly Shelter Cymru has been awarded a joint contract by the Legal Services Commission to provide a Specialist Support service in Wales. This means that other front line advice services will be able to contact Shelter Cymru for free expert advice, information and training to support their work. We have also been jointly awarded a contract to deliver a new innovative Court Duty Service in South Wales. Both of these services will be launched in 2002.

Campaigning, Policy, Training and Information services

The year proved to be one of the most significant in terms of the campaigning and policy aspirations of Shelter Cymru. In March 2001 the Welsh Assembly Government extended homeless priority need status to new groups of people including homeless 16 and 17 year olds. Shelter Cymru had been campaigning for some time for such a development and were closely linked with the new legislation.

Since its introduction our housing advice services have had a crucial role in monitoring the impact of the new law and challenging poor implementation. Our training services too have been developing new programmes to ensure that housing officers and other agencies are aware of the new duties.

During the year the Director of Shelter Cymru was invited to join the Welsh Assembly Government Homelessness Commission and the organisation's day to day casework experiences provided important data in the development of the Commission's report and recommendations. The final report reflects many of Shelter Cymru's positions, in particular moves to reduce the number of evictions of Introductory Tenants in Wales and reduce the impact of exclusions from social housing. It also proposes a National Homelessness Strategy for Wales and a model local strategy which, it is hoped will become part of statutory guidance.

Shelter Cymru's contribution to the development of the model strategy was helped by the partnership work undertaken during the year with two local authorities developing new holistic homelessness strategies. A further two similar partnerships were agreed during the year and will be undertaken in the 2001/2002 period.

Shelter Cymru continued to produce briefings, responses and to comment on a range of housing related issues. In particular two election briefings were produced in 2001 to stimulate debate over homelessness during the General Election campaign. We also hosted an Election debate published on our web site www.sheltercymru.org.uk, which was launched during the year.

Publications included, *Giving Choice a Voice*, advocating greater opportunities for homeless people to have a say over their own housing outcomes, briefings on Black and Minority Ethnic Communities and housing, responses to Social Housing Lettings, Introductory Tenancies, Supporting People, Better Homes for People in Wales and Housing Strategy developments.

Training and Information services had a particularly successful year with almost 1500 participants at training courses, seminars and conferences. Overall feedback exceeded 95% good to excellent on our training events.

Further work was also undertaken by Training Services on Learning action packs with the Disabled Facilities Grant pack distributed to over 100 organisations and the development and distribution of a new Black and Minority Ethnic community housing pack.

Training also led on the development of two new housing games designed to raise awareness of young people about homelessness and housing issues. The *Key of the Door* Game won the 2001 annual Welsh Federation of Housing Associations Pat Chown Innovation Award.

With Welsh Assembly Government support a new three year education project was launched in 2000/2001. The project aims were to initially help design and launch in Wales the BT sponsored *Housemate* schools resource which is a new teaching aid to raise awareness of homelessness among young people. The second year of the project will see the launch of a new innovative Peer Learning project enabling young people themselves to teach others about homelessness and housing problems.

Organisational Developments

Work on ensuring the organisation remains accountable to its users and other stake holders was continued through the annual consultation event linked with our AGM, and a new progress report format which directly measures our performance against the stated aims in the published three year plan.

In addition parallel with the launching of new local services during the year, a recruitment programme was introduced to encourage people to join local advisory groups. It is hoped the groups will provide vital feedback and support for our local housing advice services.

The Board of Trustees have also continued work on reviewing the knowledge and experience of current trustees and ensuring the composition of the Board reflects, as far as possible, the community it serves. During the year a new recruitment campaign successfully saw the introduction of three new trustees to the Board.

2000/01 was another successful year for Shelter Cymru in financial terms. Funding for major service developments from the Legal Services Commission, Community Fund and the Welsh Assembly Government came on stream during the year.

Sadly during the year the first Director of Shelter Cymru, Val Feld, died. The great regard many people had for Val's work, initially with Shelter Cymru then later with the Equal Opportunities Commission and as an Assembly Member, was evident at a packed memorial event at the Morriston Orpheus Tabernacle. Tributes noted her commitment to challenging social exclusion and in particular her concerns over equal opportunities and homelessness. Shelter Cymru hopes to launch a new award linking homelessness and disadvantaged groups in the name of Val Feld during the coming year.

It is important to recognise in this report the significant support for our work which comes from the Welsh Assembly Government, the Legal Services Commission, the Community Fund, Local Authorities and registered Social Landlords. It is also important to thank the many supporters, individuals, trusts, companies, community groups, schools and many others who support the work of Shelter Cymru and ensure its continued independence.

Shelter Cymru offers its congratulations and thanks to Selwyn Jones, one of our trustees. Selwyn has been a part of the organisation from the beginning, and his commitment and contribution to our work over 21 years has been enormous.

FINANCIAL REVIEW

Shelter Cymru received incoming resources of £1,602,019; of which £1,240,413 (77%) was spent on direct charitable activities, £82,821 (5%) on fundraising, and £180,278 (12%) on management and administration.

This has resulted in net incoming resources of £98,507 (6%).

Shelter Cymru aims to use the resources at its disposal as effectively as possible. It is, therefore, encouraging to report that the proportion of income spent on direct charitable activities has increased from 70% to 77%. Although actual expenditure on management and administration increased by £24,867 during the year, the major expansion of the housing advice network resulted in a lower percentage spend (down to 12% from 16% in 2000).

Fundraising is increasingly competitive. We therefore continue to move our strategy away from high risk sources and onto more sustainable, low risk areas that will provide long-term security for our services for homeless people.

Shelter Cymru's retained funds at 30th September 2001 totalled £387,090. Designated reserve funds have been set up to cover ongoing running costs (£247,122), campaigns and fundraising (£60,081), and IT and buildings maintenance (£30,000). Also, £25,000 has been set aside to raise Shelter Cymru's profile and reinforce our campaigning activity during 2002 – our 21st birthday. Restricted funds (£24,887) represent grants received for acquisition of specific assets.

A small surplus is forecast on charitable activities for the current year (ending 30th September 2002). As Shelter Cymru expands, the reserve needed to secure the organisation's longer term financial future also needs to increase. The current reserve of £247,122 represents approximately 8.5 weeks' running costs at year 2001 levels of activity (which is set to increase further during year 2002). This compares with the organisation's target level of 3 months' running costs. It therefore remains a priority to build our reserves to provide more security and the capacity and flexibility to respond to challenges in the future.

All assets are held to achieve the objects of the charity.

TRUSTEES

The trustees who served during the year under review are listed on page 1. Trustees are appointed by Board members on a four year basis and must stand for re-election at the end of this period if they wish to remain a Board member. After serving two four year terms, Trustees are required to stand down for at least a year before they are eligible for re-election.

The company is a registered charity, limited by guarantee and not having a share capital. None of the Directors has a personal financial interest in the company.

FIXED ASSETS

Changes in fixed assets during the year are set out in note 6 to the financial statements.

TAXATION STATUS

The company is a registered charity and has no tax liability on the surplus for the year.

AUDITORS

In accordance with S385 of the Companies Act 1985, a resolution proposing the reappointment of Bevan & Buckland as auditors will be proposed at the forthcoming Annual General Meeting.

The charity is governed by its articles of association and its constitution registered under the Charities Act. The charity is restricted to carrying out activities within its charitable objects.

1. ACCOUNTING CONVENTION

The financial statements are prepared under the historical cost convention.

The company has taken advantage of the exemption from preparing a cashflow statement conferred by Financial Reporting Standard No 1 on the grounds that it is entitled to the exemptions available in Section 246 to 247 of the Companies Act 1985 for small companies.

2. TURNOVER

Turnover represents Revenue Grants, Donations and Legal Fees.

3. STOCKS

Stocks are valued at the lower of cost and net realisable value. Cost represents invoice purchase price.

4. **DEPRECIATION**

Depreciation is provided at rates estimated to write off the cost of fixed assets over the expected useful working life of those assets.

5. REPAIRS AND RENEWALS

Repairs and renewals expenditure is written off in the accounting period in which the expenditure is incurred.

6. PENSION CONTRIBUTIONS

Pension scheme defined contributions are made by the company to the funds, the assets of which are held separately from those of the company. The pension costs in the income and expenditure account represent the amount of the contribution payable in respect of the accounting period.

7. GRANTS RECEIVABLE - SOFA

Grants for immediate expenditure are accounted for when they become receivable. Grants received for specific purposes are treated as restricted funds. Grants restricted to future accounting periods are deferred and recognised in these periods.

8. ALLOCATION OF FUNDS

Costs are allocated between direct charitable and other expenditure according to the nature of the cost. Where items include more than one category they are apportioned between the categories according to the nature of the cost.

9. VOLUNTARY INCOME

Voluntary income is received by way of donations, grants and fundraising events and is included in the Statement of Financial Activities and Income and Expenditure Account when received.

10. GOVERNMENT GRANTS - SUMMARY INCOME & EXPENDITURE ACCOUNT

Revenue grants are credited to the income and expenditure account during the period of expenditure. Capital grants are credited to restricted reserves and the depreciation on the assets to which they relate is charged to the Income and Expenditure account as restricted expenditure.
