#### 8. RELEVANT CONTRACTS

- (a) Subject to paragraph (b) below, each Chargor assigns absolutely by way of security, subject to a proviso for re-assignment on redemption, all of its rights in respect of its Relevant Contracts including all damages, compensation, remuneration, profit, rent or income which that Chargor may derive from that right or be awarded or entitled to in respect of that right.
- (b) To the extent that any right described in paragraph (a) above is not assignable or capable of assignment, the assignment of that right purported to be effected by paragraph (a) shall operate as an assignment of any damages, compensation, remuneration, profit, rent or income which that Chargor may derive from that right or be awarded or entitled to in respect of that right.
- (c) To the extent that they do not fall within any other subclause of Clause 2.8 (*Relevant contracts*) of the Debenture and are not effectively assigned under paragraph (a) or (b) above, each Chargor charges by way of first priority fixed charge all of its rights under each agreement and document to which it is a party.

#### 9. INTELLECTUAL PROPERTY

This includes:

(i) the re-execution of the Debenture;

## 16. NEGATIVE PLEDGE

(b) all other shares, stocks, debentures, bonds, warrants, coupons and other securities and investments,

which a Chargor purports to mortgage or charge under the Debenture.

Issue Date means the date on which (i) the Indenture is released and becomes effective pursuant to the Escrow Agreement and (ii) the Securities are issued.

Issuer means Castle Holdco 4, Ltd.

Issuer Scheme or Issuer Schemes means the schemes of arrangement in respect of the Issuer under section 895 of the Companies Act and section 86 of the Cayman Companies Law sanctioned by the High Court of Justice of England and Wales and the Grand Court of the Cayman Islands and the transactions related thereto and contemplated therein.

Shares means all shares in any member of the Group the subject of the Security.

Subsidiary means, with respect to any Person, (1) any corporation, association or other business entity (other than a partnership, joint venture or limited liability company) of which more than 50% of the total voting power of shares of Capital Stock entitled (without regard to the occurrence of any contingency) to vote in the election of directors, managers or trustees thereof is at the time of determination owned or controlled, directly or indirectly, by such Person or one or more of the other Subsidiaries of that Person or a combination thereof, and (2) any partnership, joint venture or limited liability company of which (x) more than 50% of the capital accounts, distribution rights, total equity and voting interests or general and limited
