**NOTES TO THE ACCOUNTS**

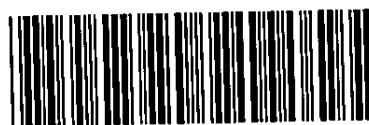
1. For the year ended 29 March 2008 the company was entitled to exemption under section 249AA(1) of the Companies Act 1985
