THE ENTITLED TO RECEIVE IN PRIORITY TO OTHER CLASSES OF SHARES, OUT OF THE PROFITS RESOLVED TO BE DISTRIBUTED, A FIXED PREFERENCIAL DIVIDEND AT 10% PER ANNUM PAYABLE HALF YEARLY. RETURN OF CAPITAL THE RIGHT TO RECEIVE ON A WINDING UP OR OTHER REPAYMENT OF CAPITAL IN PRIORITY TO THE ORDINARY SHAREHOLDERS. THE AMOUNT PAID UP THEREON TOGETHER WITH ANY ARREARS OF THE FIXED PREFERENCIAL DIVIDEND BUT WITH NO FURTHER RIGHT TO PARTICIPATE IN ANY SURPLUS CAPITAL OF THE COMPANY. WHERE PREFERENCE SHAREHOLDERS DO HAVE THE RIGHT TO VOTE, EVERY MEMBER PRESENT IN PERSON OR BY PROXY SHALL HAVE ONE VOTE ON SHOW OF HANDS AND ON A POLL, THEY SHALL HAVE ONE VOTE IN RESPECT OF EACH PREFERENCE SHARE HELD.
