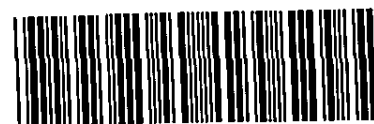

There have been no receipts or payments in the liquidations of the Companies


