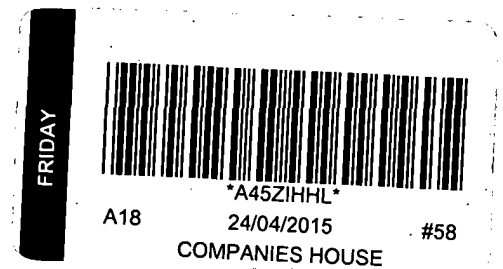

### **Results and review of the business**


The company was dormant under the terms of Section 386 of the Companies Act 2006 during the period.

## **Directors' responsibilities statement**

The directors are responsible for preparing the directors' report and the financial statements in accordance with applicable law and regulations.


