The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed an investment in Esprit Vacations Limited, a debt due from Enigma Holidays Limited, the Company's immediate parent and an inter-company debt due to Esprit Vacations Limited.

A liquidation distribution was received of £1,992 from the liquidation of Esprit Vacations Limited. The distribution was effected by set off against the inter-company debt due by the Company to Esprit Vacations Limited.

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette and the Times newspaper on 22 and 23 August 2013 respectively. No creditors were forthcoming as a result of these advertisements.

A search of the Index of Proprietors' Names at HM Land Registry proved negative.

Tax

All pre-liquidation corporation tax matters were handled by KPMG Tax who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ("HMRC"). At the request of the Joint Liquidators HMRC subsequently confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Liquidators taking steps to bring the liquidation to a conclusion.

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters.

During the liquidation a claim was received from the Austrian tax authorities and following discussions confirmation was received that pursuant to section 160(3) of the Federal Tax Code no claims existed in the commercial register.

Distributions

On 8 December 2017 the Joint Liquidators declared a first and final distribution of the assets of the Company to Enigma Holidays Limited, as the sole beneficial shareholder of the Company.

The distribution was at the rate of £1.00104 per £1 ordinary share and was effected by set off against the debt of £50,052 due to the Company by Enigma Holidays Limited.

Change of Liquidator

On 4 October 2016 an order was made in the High Court appointing Mark Orton as Joint Liquidator of the Company in place of Allan Graham, following Allan Graham's retirement from KPMG LLP.

In accordance with the order, members were given notice of the replacement of Allan Graham as Joint Liquidator by advertisement in the London Gazette.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 9 August 2013 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the Liquidators' remuneration has been paid by Hotelplan (U.K. Group) Limited and accordingly no detailed analysis is included in this report.

In certain circumstances, additional information regarding the Joint Liquidators' remuneration and/or other expenses charged for the period may be requested from the Joint Liquidators within 21 days of receipt of this report, in accordance with Rule 18.9 and 18.34. In addition, the quantum may be challenged by making an application to Court within eight weeks of receipt of this report, in accordance with Rule 18.34. The full text of these rules can be provided upon request.
