- 1 "Director" includes any person who occurs the position of a director by whatever name called, and any person in accordance with whose directions or instructions the directors of the company are accustomed to act
- 2 For an individual, his present Christian furne(s) and silmame must be given sogether with any previous Christian name(s) or sumame(s)

'Christian name includes a forename in the case of a peer or person usually known by a title different from his surname, 'surname' means that title in the case of a corporation, it, corporate rules roust he given

A previous Cirnstan name or surnants need not be given if --

- (b) it was changed or ceased to be used at least 20 years ago or before the person v his previously used it reached the age of 18 or

- (a) a dormant company (which is a company which has had no transactions required to be entered in the company s accounting records, except and which may have arisen from the taking of shares in the company by a subscriber to the memorandum as such).
- (b) a body corporate of which the company making the retuil was a wholly owned subsidiary.
- (c) a wholly owned subadiery of the company making the return or
- (d) a wholly-owned subsidiary of a body corporate of which the company risking the raturn was also a wholly owner subsidiary
