## Motes

- 1 "Director" includes any parton who couples the position of a director, by whether name called, and any serion in sectobase with whose directors or instructions the directors of the convery are counterned to act.
- For an individual, his present christian nametal and auments must be given, together with any provious christian name(s) or surnemat(s).

"Christian name" includes a forename. In the case of a past or parson usually income by a title different from his aurusma, "sumanne" means that title. In the case of a corporation, its corporate name must be given.

A previous christien name or sumame need not be given if:—

- (s) in the case of a married woman, it was a name by which she was known before her marriege; or
- (b) it was changed or resead to be used at least 20 years ago, or before the person who praviously used it reached the age of 18; or
- (c) in the case of a peer or a person usually known by a British title different from his aumame, it was a name by which he was known before he adopted the title or succeeded to it

8 Where all the partners in a firm are joint repretents, only the firm name and its principal office need be given.

Where the scenetary or one of the joint secretaries is a Socitish firm, give only the firm name and its principal office.

- 4 Usual residential address must be given. In this case of a corporation, sive the registered or principal office.
- 5 Date of birth need only be given if the company making the return is:—

(a) a public company;
(b) the subsidiary of a public company; or —
(c) the subsidiary of a public company registered in Northern iretand

The names must be given of all bodies corporate incorporated in Great Britain of which the director is also a director, or has been a director at any time during the preceding five years.

However a present or past directorship need not be disclosed if it is, or has been, held in a body corporate which, throughout that directorship, has been:— (a) a derment company (which is a company which has had no transactions required to be entered in the company's according records, according to the company have also from the taking of siteres in the company by a subsigilier to the memorandum as such).

(b) a body corporate of which the company making the return was a wholly-owned subsidiary:

(c) a wholly-owned subsidiary of the company making the return;
