Statement of Directors' responsibilities



For the year ended 30 September 2005 the Company was entitled to exemption from the requirement to have an audit under the provision of Section 249AA(1) of the Companies Act 1985.


No notice has been deposited with the company under Section 249B(2) of that Act requiring an audit to be carried out.
