- 2. Darren Edwards and Isobel Brett be discharged from liability in respect of any action of them as Joint Administrators in accordance with paragraph 98 of Schedule B1 of the Insolvency Act 1986.
- 3. BEAUMONT BEDS LIMITED, registered number 01926530, be wound be up by the court under the provision

- 4. Darren Edwards of Aspect Plus Limited 40a Station Road, Upminster, Essex, RM14 2TR be appointed as liquidator of BEAUMONT BEDS LIMITED pursuant to section 140(1) of the Insolvency Act 1986.
- 5. The Petitioners' costs of and incidental to the said petition be paid as an expense of the administration.
