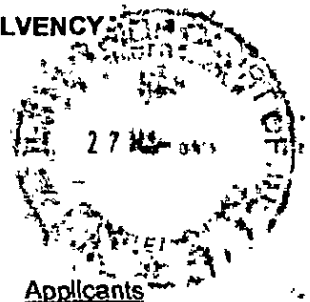

AND UPON reading the witness statements of Martin Daley and Simon Blakey dated  
February 2017.

IT IS ORDERED THAT:

1. The insolvent administrations referred to in the Schedule attached to this Order ("the Schedule") are hereby transferred to the High Court of Justice, Chancery Division, Newcastle upon Tyne District Registry for the purposes only of the following paragraphs of this Order and immediately upon the following paragraphs taking effect the insolvency administrations will revert to the respective courts listed under the distinct reference numbers and it is directed that the court file relating to each insolvent administration shall not be transferred to the Newcastle

upon Tyne District Registry whether for the purposes of this Order or otherwise.

2. In relation to the insolvent administrations listed in the Schedule Martin Daley be removed as Joint Office Holder of each of the listed insolvent appointments and Simon Blakey remain as the appointed Office Holder.
3. The effective date of the removal in respect of the insolvency administrations will be the date of this order.
4. Simon Blakey ("the Remaining Insolvency Practitioner") shall file and serve a copy of this Order on each of the respective courts shown in the Schedule.
5. The Remaining Insolvency Practitioner shall place one advert in the London Gazette within 28 days of the date of this Order giving notice of the provisions of this Order.
6. Any creditor (or members in the case of members' voluntary liquidations) who objects to the transfer of an insolvency appointment as provided by this Order shall have a period of 28 days from the date of the advert to apply to court to set aside or vary the terms of this order. However such application shall not affect the transfer of the insolvency appointments by this Order until further or other order by the court.
7. Martin Daley shall receive his release as Supervisor, Liquidator or Trustee 7 days after the advert is placed in the London Gazette, save that such release may be subject to further order in the event of an application by any creditor as referred to at paragraph 6 above for the specific case subject to that application.
8. The Remaining Insolvency Practitioner shall attach a copy of this order to the next statutory report for each insolvency administration listed in the Schedule.
9. This Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in the Schedule and the current time limit for reporting to creditors on each of the insolvency appointments shall continue irrespective of the removal and appointments made by this Order.
10. The provisions contained in Insolvency Rules 2.47(3A), 4.49B(5), 4.49C(3) and 6.78A(4) of the Insolvency Rules 1986 or any other such reporting requirements shall not apply and Martin Daley is not required to produce any progress reports on ceasing to act as office holder of the insolvency appointments listed in the Schedule.
11. Martin Daley shall not be required to submit a D Report in respect of any of the

Voluntary Liquidations listed in the Schedule pursuant to Rule 4(5)(b) Insolvent Companies (Report on Conduct of Directors) Rules 1996 and such reporting obligations shall be carried out by the Remaining Insolvency Practitioner as required in each case.

12. The Remaining Insolvency Practitioner shall notify the Secretary of State and the Registrar of Companies (for any company insolvency appointment) of the terms of this Order as soon as reasonably practicable.
13. The costs of making this application, advertising this Order in the Gazette and carrying out the steps required by this Order shall be apportioned equally between the cases listed in the Schedule and the pro-rata share of the cost shall be payable as an expense of the administration appointment or insolvency proceedings of the insolvency appointments as the case may be.
