Until June 2009, the Company acted as an intermediate holding company of a subsidiary of the British American Tobacco p I c Group (the "Group")

# Review of the year to 31 December 2009

During the financial year under consideration, the Company transferred its investment in Murray, Sons & Company, Limited to B A T (U K and Export) Limited, which resulted in a profit of £1 00 (2008 £nil)

The Company did not trade and received no income and incurred no expenditure other than the gain on the transfer of its investment

The Directors expect the Company's activities to continue on a similar basis in the foreseeable future

### Key performance indicators

The Directors of British American Tobacco p I c , the ultimate parent company, manage the operations of the Group on a regional basis. For this reason, and given the nature of the Company's activities, the Company's Directors believe that key performance indicators are not necessary or appropriate for an understanding of the Company's specific development, performance or the position of its business. However, key performance indicators relevant to the Group, and which may be relevant to the Company, are disclosed under the Business Review section in the Annual Report of British American Tobacco p I c and do not form part of this report.

#### 1 Accounting policies

A summary of the principal accounting policies is set out below

#### (1) Basis of accounting

The financial statements are prepared on the going concern basis, under the historical cost convention, and in accordance with the Companies Act 2006 and applicable accounting standards in the United Kingdom

#### (2) Cash flow statement

The Company is a wholly-owned subsidiary of British American Tobacco p I c The cash flows of the Company are included in the consolidated cash flow statement of British American Tobacco p I c which is publicly available. Consequently the Company is exempt under the terms of FRS 1 (Revised) from publishing a cash flow statement.

#### (3) Foreign currencies

Transactions arising in currencies other than sterling are translated at the rate of exchange ruling on the date of the transaction. Monetary assets and liabilities expressed in currencies other than sterling are translated at rates of exchange ruling at the end of the financial year. All exchange differences are taken to the profit and loss account in the year.

#### (4) Taxation

Taxation provided is that chargeable on the profits of the year, together with deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date, where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date

Deferred tax is measured at the average tax rates that are expected to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax is measured on an undiscounted basis

#### (5) Fixed asset investments

Fixed asset investments are stated at cost less provisions for any impairment in value

#### 2 Operating charges

Audit fees of £100 were borne by a fellow Group undertaking (2008 £100)
