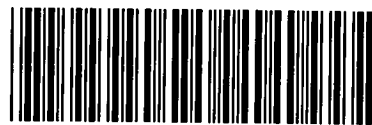

Strategic Report

Year ended 31 March 2022

Who we are and what we do

NHBC Building Control Services Limited ("BCS", "the Company") was established in 1985 and is the largest single building control body in England and Wales. BCS is regulated and licensed by the Construction Industry Council Approved Inspectors Register (CICAIR) and provides building control on residential, mixed-use and commercial projects, providing support and technical advice to builders and their agents.

Our strategy and objectives

Our business strategy is focussed on ensuring we are effective in meeting our role in the regulatory system, providing services that support the National House-Building Council's objective of raising standards in house-building.

Principal risks and uncertainties

The management of the business and the execution of the Company's strategy are subject to a number of risks and uncertainties.

The key business risks and uncertainties affecting the Company relate to legislative changes which may limit our potential market, increased competition from other building control bodies with potential business loss through builder defection.

The Building Safety Act 2022 (the "Act") has received Royal Assent and will introduce many of the recommendations of the Independent Review of Building Regulations and Fire Safety led by Dame Judith Hackitt commissioned following the Grenfell Tower tragedy. The Act provides the legal framework for a new national Building Safety Regulator ("BSR") within England, with the BSR being established in shadow form within the Health and Safety Executive. We continue to engage with Government and the BSR to help establish effective building regulations and practices. Secondary legislation will be required to implement the new regulatory system for building safety, with this having the potential to affect significantly BCS's activities, especially in relation to high rise residential buildings. The Welsh Assembly Government has confirmed that BCS and other Approved Inspectors will be restricted from offering its services to customers building high rise residential buildings in Wales.

The industry's recovery from the impact of the pandemic aided by demand-side stimulus from Government through help to buy has bolstered the volume of new homes being built. The increase in homes built for private sale has seen an uplift in customers who take both warranty and building control from NHBC. In BCS, we retain the resource and expertise to ensure regulatory functions are discharged and service is delivered to customers to the standard required.

Financial risk management objectives and policy have not been disclosed as the directors believe the disclosure is not material to users' understanding of the Company's financial statements.

The Company's risks and uncertainties are considered and reviewed by the BCS Board at each Board meeting with action being recommended and taken as appropriate.

Review of the year

The number of new homes registered with the Company for residential building control was 50.1% higher than the previous financial year whilst completion volumes increased by 18.8%. Total turnover increased by 37.2% in the financial year with the Company recording a profit before taxation of £1,604,869 (2021: £543,669). After allowing for corporation tax, shareholders' funds have increased to £6,452,410 (2021: £4,847,510).

Given the straightforward nature of the business, the Company's directors are of the opinion that detailed analysis using KPIs is not necessary for an understanding of the development, performance or position of the business.

Outlook

Although higher inflation, interest rates and energy prices create recessionary pressures, BCS's prospects are closely associated with house building which is likely to out-perform many other sectors of the UK economy. The Board continues to monitor market activity and economic prospects, placing emphasis on customer service and on core competencies within BCS. The business will continue to invest in resources which will allow it to meet future challenges and to return a satisfactory level of profit to the National House-Building Council.

BCS will continue to engage with Government and other stakeholders as the Building Safety Act 2022 is implemented and the effect on building control becomes clear. This should mitigate the risk of BCS being deflected from its business objectives and strategy.

Corporate governance

The Company is a wholly owned subsidiary of the National House-Building Council. The Board of BCS ensures that the Company achieves an appropriate standard of governance having regard to its constitution and the regulatory framework in which the Company operates.

Opinion

In our opinion the financial statements of NHBC Building Control Services Limited (the Company):

- give a true and fair view of the state of the Company's affairs as at 31 March 2022 and of its profit for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'; and

We obtained an understanding of the legal and regulatory framework that the Company operates in, and identified the key laws and regulations that:

- had a direct effect on the determination of material amounts and disclosures in the financial statements. These included UK Companies Act (2006) and tax legislation; and
- do not have a direct effect on the financial statements but compliance with which may be fundamental to the Company's ability to operate or to avoid a material penalty.

We discussed among the audit engagement team regarding the opportunities and incentives that may exist within the organisation for fraud and how and where fraud might occur in the financial statements.

The company's key revenue stream is through inspections of new build homes throughout the construction process. An assumption is used around the stage of completion to recognise these revenues. We have assessed that there is a significant risk of material misstatement relating to revenue recognition which is pinpointed to this assumption.

- We have obtained an understanding of the revenue process, including procedures for determining this assumption is accurate and appropriate;
- Assessed the design and implementation of controls in the revenue process specifically focusing on this assumption; and
- Assessed the assumptions used by management, through review and challenge of supporting and evidence and understanding of any contradictory evidence.

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. In addressing the risk of fraud through management override of controls, we tested the appropriateness of journal entries and other adjustments; assessed whether the judgements made in making accounting estimates are indicative of a potential bias; and evaluated the business rationale of any significant transactions that are unusual or outside the normal course of business.

In addition to the above, our procedures to respond to the risks identified included the following:

- reviewing financial statement disclosures by testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- enquiring of management and in-house / external legal counsel concerning actual and potential litigation and claims, and instances of non-compliance with laws and regulations; and
- reading minutes of meetings of those charged with governance and reviewing internal audit reports.

1. General information

The company is a private company limited by shares, registered in England and Wales. The address of the registered office is NHBC House, Davy Avenue, Knowlhill, Milton Keynes, Bucks, MK5 8FP.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis.

Going concern

After reviewing the Company's forecasts and projections, the directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. The Company therefore continues to adopt the going concern basis in preparing its financial statements. The Company's Board of directors have considered the effect of Covid-19 in their assessment of the Company's going concern.

Disclosure exemptions

The entity satisfies the criteria of being a qualifying entity as defined in FRS 102. Its financial statements are consolidated into the financial statements of National House-Building Council which can be obtained from The Secretary, NHBC, NHBC House, Davy Avenue, Knowlhill, Milton Keynes, Bucks, MK5 8FP. As such, advantage has been taken of the disclosure exemptions available under paragraph 1.12 of FRS 102.

- (a) No cash flow statement has been presented for the company.
- (b) Disclosures in respect of financial instruments have not been presented.
- (c) No disclosure has been given for the aggregate remuneration of key management personnel.

Judgements and key sources of estimation uncertainty

There are no significant judgements in preparation of the Company's financial statements. Revenue recognition is a significant estimate in preparation of the Company's financial statements.

Revenue recognition

Turnover is measured at the fair value of the consideration received or receivable for goods supplied and services rendered, net of discounts and Value Added Tax.

Revenue from the sale of goods is recognised when the significant risks and rewards of ownership have transferred to the buyer (usually on despatch of the goods); the amount of revenue can be measured reliably; it is probable that the associated economic benefits will flow to the entity; and the costs incurred or to be incurred in respect of the transactions can be measured reliably.

Revenue recognition *(continued)*

Revenue from the rendering of services is measured by reference to the stage of completion of the service transaction at the end of the reporting period provided that the outcome can be reliably estimated. When the outcome cannot be reliably estimated, revenue is recognised only to the extent that it is probable the expenses recognised will be recovered.

Income tax

The taxation expense represents the aggregate amount of current and deferred tax recognised in the reporting period. Tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, tax is recognised in other comprehensive income or directly in equity, respectively.

Current tax is recognised on taxable profit for the current and past periods. Current tax is measured at the amounts of tax expected to pay or recover using the tax rates and laws that have been enacted or substantively enacted at the reporting date.

Deferred tax is recognised in respect of all timing differences at the reporting date. Unrelieved tax losses and other deferred tax assets are recognised to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits. Deferred tax is measured using the tax rates and laws that have been enacted or substantively enacted by the reporting date that are expected to apply to the reversal of the timing difference.

15. Controlling party
