DIRECTORS' REPORT

The Directors present their report and the audited financial statements for the year ended 31 March 2014.

Business review and principal activities

The principal activity of the Company is that of an investment company.

The profit on ordinary activities before tax for the year ended 31 March 2014 was £54,731 (2013: £54,732). No dividend has been paid or proposed in the year (2013: £nil). The retained profit transferred to reserves for the year was £42,143 (2013: £41,596).

Principal risks and uncertainties

The Company is a wholly-owned subsidiary of Shanks Group plc. Risks are managed at a local level in accordance with the risk management framework of Shanks Group plc. The principal risks and uncertainties of Shanks Group plc are discussed in its Annual Report and Accounts for the year ended 31 March 2014.

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.



Report on the financial statements

Our opinion

In our opinion the financial statements, defined below:

- give a true and fair view of the state of the company's affairs as at 31 March 2014 and of its profit for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

This opinion is to be read in the context of what we say in the remainder of this report.

What we have audited

The financial statements, which are prepared by Shanks & McEwan (Environmental Services) Limited, comprise:

- the balance sheet as at 31 March 2014;
- the profit and loss account and statement of total recognised gains and losses for the year then ended; and
- the notes to the financial statements, which include a summary of significant accounting policies and other explanatory information.

The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

In applying the financial reporting framework, the directors have made a number of subjective judgements, for example in respect of significant accounting estimates. In making such estimates, they have made assumptions and considered future events.



1 Accounting policies

Basis of preparation

The financial statements have been prepared on a going concern basis, under the historical cost convention and in accordance with applicable law, the Companies Act 2006 and in accordance with applicable Accounting Standards in the United Kingdom (UK Generally Accepted Accounting Practice). The accounting policies set out below have been consistently applied.

Taxation

Current tax payable is based on taxable profit for the year. Taxable profit differs from profit before tax in the profit and loss account because it excludes items of income and expense that are taxable or deductible in other years or that are never taxable or deductible.

2 Segmental reporting

The Company operates solely in the United Kingdom and receives interest income from fellow subsidiary undertakings.

3 Company status

Audit costs have been borne by the ultimate parent company. There were no employees of the Company in the year. The Directors were not remunerated for their services to the Company, neither did the Directors accrue any retirement benefits in respect of service to the Company. None of the emoluments paid to the Directors by the other group companies during the year related to services given to the Company.

11 Contingent liabilities

The Company has granted to its bankers an unlimited guarantee and a right of set off against amounts outstanding on advances to its parent and fellow subsidiary undertakings. As at 31 March 2014 the Group borrowings for which the Company was a co-guarantor were £84,771,082 (2013: £158,638,000).

The Company has given an unlimited guarantee in respect of the Group's retail bonds totalling £165,343,915 (2013: £84,566,596).

In respect of contractual liabilities the Company, along with other fellow group undertakings, has given guarantees and entered into counter indemnities of bonds and guarantees given on their behalf by sureties and banks totalling £61,739,229 (2013: £79,762,000).

The Company is a member of a HMRC Group VAT registration and as at 31 March 2013 had a contingent liability of £985,878 (2013: £4,682,259) under this registration.

The Company is also a member of a HMRC Group Payment arrangement for Corporation Tax and as at 31 March 2013 had a contingent liability of £nil (2013: £nil) under this arrangement.

12 Related party transactions

As permitted by FRS 8, the Company, being a wholly-owned subsidiary of another company which prepares a statement of related party transactions including that of this Company, has not prepared such a statement itself.

13 Cash flow statement

The Company is a wholly-owned subsidiary of Shanks Group plc and is included in the consolidated statements of Shanks Group plc, which are publicly available. Consequently, the Company has taken advantage of the exemption from preparing a cash flow statement under the terms of FRS 1.

14 Immediate and ultimate parent company

The Company's immediate parent company is Shanks Capital Investment Limited, a company incorporated in England & Wales, and the ultimate parent company and controlling party is Shanks Group plc, a company registered in Scotland.
