## **Directors' report**

The Directors present their report and unaudited financial statements of British Electricity International (OS) Limited (the Company) for the year ended 31 December 2015.

## **Principal activities and business review**

The Company is a dormant company and holds an amount owed by a group undertaking. The Company did not trade during the financial year or the preceding financial year.

The accompanying financial statements have been prepared in accordance with Financial Reporting Standard 102 *The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland* (FRS 102) for both periods presented. The application of FRS 102 represents a transition from reporting under previous UK GAAP, which was applied in the preparation of last year's financial statements. There were no recognition or measurement differences arising on the adoption of FRS 102.

## **Dividends**

The Directors do not recommend the payment of a dividend in respect of the year ended 31 December 2015 (2014: £nil).

## **Principal risks and uncertainties**

Owing to the limited nature of the activities of the Company during the year and constituent elements of its balance sheet, the Directors do not believe there are any material risks or uncertainties that require disclosure in order to provide an understanding of the position of the Company at 31 December 2015 or its future prospects.

## **Share capital**

The Company's share capital comprises one hundred ordinary shares of £1.00 each which rank pari passu with each other in respect of all rights, including dividend, voting and return of capital.

## **Going concern**

The Company has available to it the resources and support of one of its intermediate parent companies, International Power Ltd.. Accordingly, the Directors continue to adopt the going concern basis in preparing the financial statements.

## **Exemption from audit**

For the year ended 31 December 2015 the Company was entitled to exemption under Section 480(1) of the Companies Act 2006. No members have required the Company to obtain an audit of its financial statements for the financial year in accordance with Section 476(1) to (3).

## **Events after the end of the reporting period**

There have been no significant events since the reporting date which should be considered for a proper understanding of these financial statements.

**Statement of Directors' responsibilities in respect of the Directors' report and the financial statements**

The Directors are responsible for preparing the Directors' report and the financial statements in accordance with applicable law and regulations.

Company law requires the Directors to prepare financial statements for each financial year. Under that law they have elected to prepare the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards and applicable law), including FRS 102.

In preparing these financial statements, the Directors are required to:

- select suitable accounting policies and then apply them consistently;

- state whether applicable United Kingdom Accounting Standards, including FRS 102, have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

The Directors are responsible for keeping adequate accounting records that are sufficient to show and explain the Company's transactions and disclose with reasonable accuracy at any time the financial position of the Company and enable them to ensure that its financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.



**1. The reporting entity**

British Electricity International (OS) Limited (the Company) is a company incorporated in the United Kingdom. The address of the Company's registered office is Level 20, 25 Canada Square, London E14 5LQ. The Company is a dormant company that holds an amount owed by its parent undertaking.

**2. Accounting policies**

*Basis of preparation*

The financial statements have been prepared under the historical cost convention and in accordance with the applicable United Kingdom accounting standards, including Financial Reporting Standard 102 *The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland* (FRS 102).

This is the first year in which the financial statements have been prepared under FRS 102. There are no amendments on the adoption of FRS 102 (refer to note 7).

*Cash flow statement*

As there are no transactions that result in cash flows of the Company during the year and the preceding financial year, no cash flow statement is presented.

*Amounts owed by group undertakings*

Amounts owed by group undertakings are carried at amortised cost using the effective interest method less any allowance for estimated impairment.

**3. Directors' and employees' remuneration**

The Directors did not receive any fees or emoluments during the year directly attributable to their position within the Company (2014: £nil). All Directors' fees or emoluments were paid by International Power Ltd. and the amount attributable to the qualifying services provided by the Directors to the Company cannot be reliably estimated. The Company had no employees during the year (2014: nil).

**6. Controlling party and ultimate parent undertaking**

The Company's immediate parent undertaking is British Electricity International Limited, the registered address is Level 20, 25 Canada Square, London E14 5LQ, United Kingdom.

The Directors consider the Company's ultimate parent undertaking and controlling party to be ENGIE S.A. (formerly GDF SUEZ S.A.) which was incorporated in France and is headquartered in Paris, France and which is the parent undertaking of the largest and smallest group in which the results of the Company are consolidated for the year ended 31 December 2015 and the year ended 31 December 2014. The consolidated financial statements of ENGIE S.A. may be obtained from its registered office at 1 Place Samuel de Champlain, 92400 Courbevoie, Paris, France.

**7. Explanation of transition to FRS 102**

For all periods up to and including the year ended 31 December 2014, the Company prepared its financial statements in accordance with previously extant UK GAAP. These financial statements, for the year ended 31 December 2015, are the first the Company has prepared in accordance with the requirements of FRS 102.

The Company continues to meet the definition of 'dormant' under the Companies Act 2006 because the transition to FRS 102 has not resulted in any significant accounting transactions.

The transition to FRS 102 has no impact on the opening position which was previously prepared in accordance with the previous UK GAAP basis of accounting.
