FINANCIAL ASSISTANCE SUMMARY

1 Overview

1.1 Definitions

For the purposes of this summary, the following definitions shall have the following meanings:

"Acquisition" means the acquisition by Harrock of the Shares;

"Act" means the Companies Act 1985 (as amended from time to time);

"Bank of Scotland Facility" means the facility agreement between Harrock, as Parent (1) The Governor and Company of the Bank of Scotland, as Agent, Arranger, Issuing Bank and Clearing Bank (2) and the Banks listed therein dated 2nd March 1999 as amended by a supplemental facility agreement dated 9th March 2000;

"Cash Offer" means the recommended cash offer dated 11 March 2000 by Noble Grossart Limited on behalf of Harrock to acquire the entire issued share capital of Wainhomes (other than the issued share capital of Wainhomes already owned by Harrock).

"Harrock" means Harrock Limited (Company number 03621554);

"Shares" means 63,106,003 ordinary shares at 10p each in the capital of Wainhomes;

"Wainhomes" means Wainhomes Limited (Company number 01986430);

"Wainhomes Support Agreement" means the intra-group loan agreement from Wainhomes to Harrock.

2 Financial Assistance in relation to the Acquisition

- 2.1 Harrock funded the Acquisition with the Bank of Scotland Facility.
- 2.2 The financial assistance to be given by Wainhomes will take the form of Wainhomes entering into and, subject to the terms thereof, performing each of its obligations under the Wainhomes Support Agreement.
- 2.3 The entering into and performance by Wainhomes of its obligations under the Wainhomes Support Agreement will assist Harrock by lending money to Harrock which will be used to repay the Bank of Scotland Facility and will therefore be reducing or discharging the liabilities incurred by Harrock in relation to the Acquisition.
