### Articles of Association Clause 34 be changed to read

"All moneys received by the association shall be regularly paid into the banking account or one of several banking accounts to be kept in the name of the association, and no money shall be paid by or on account of the association, other than petty cash disbursement, except by cheque or by authorised electronic banking means on a banking account

Petty cash disbursements shall be paid out of cash for which cheques on a banking account shall be drawn from time to time as required

All cheques or electronic banking payments on a banking account shall be signed and countersigned or in the case of electronic banking authorised and counter authorised as may from time to time be authorised by the council

Council may authorise one or more members of the executive management team to use a bank direct debit card and/or Company Credit Card to make payments as and

when necessary for the effective and efficient purchase of goods or services Such card(s) to be subject to maximum limits laid down from time to time by the Council"

Changes to Clause 34 do not require the approval of the Charity Commission

The meeting instructs the company secretary to submit certified copies of the special resolutions to the Charity Commissioners and amended Memorandum and Articles of Association to Companies House within 15 days of the AGM
