The balance sheet on page 5 of the Financial Statements shows the Company's financial position at the year end Net assets have decreased due to the interim dividend being paid during the year Details of amounts owed from other group companies are shown in note 4

The directors recommend no final dividend (2009 £nil) which, given the interim dividend of 42.9 pence per share (2009 £nil per share), means a total dividend for the year of 42.9 pence per share (2009 £nil per share)

The Group manages its operations on a centralised basis For this reason, the Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business

The Company's primary financial assets and liabilities are with other group companies, therefore the directors do not consider that the Company is exposed to any significant cash flow, credit or liquidity risks

1. ACCOUNTING POLICIES

The Financial Statements are prepared in accordance with applicable UK Accounting Standards. The particular accounting policies adopted are described below. Accounting convention
