

Short particulars

With effect from the deed dated 11 May 2012 between Barclays Bank PLC (the "Security Agent") and Brake Bros Limited (the "Chargor") (the "Release Deed"), the Security Agent irrevocably and unconditionally, without recourse, representation or warranty of title
