I enclose for your information an annual progress report in accordance with Section 92A of the Insolvency Act 1986 and Rule 4.49C of the Insolvency Rules 1986 for the period 10 April 2015 to 9 April 2016.

Statutory Information

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as Liquidator of the Companies on 10 April 2015.

The Companies' registered numbers are detailed above. Their former names are detailed in the attached Schedule A. They do not have any other trading styles.

Following my appointment, the UK Companies' registered office was changed to 55 Baker Street, London, W1U 7EU and the Scottish Companies' registered office was changed to 4 Atlantic Quay, York Street, Glasgow, G2 8JX

The Companies are all subsidiaries of the VION Food Group ("VION")

Receipts and Payments

There have been no receipts or payments in the liquidation period.

BDO LLP, a UK limited liability partnership registered in England and Wales under number OC305127, is a member of BDO International Limited, a UK company limited by guarantee, and forms part of the international BDO network of independent member firms. A list of members' names is open to inspection at our registered office, 55 Baker Street, London W1U 7EU BDO LLP is authorised and regulated by the Financial Conduct Authority to conduct investment business

The Companies' assets are comprised of intercompany debtor balance owed by group companies. These amounts will be distributed in specie to their espective shareholders prior to the final meetings of members being held.

In addition to the above, Cymru Country Produce Limited owns the entire share capital of VION Subco GCF Limited and Cymru Country Feeds Limited, and will receive distributions in specie from those companies which will in turn be distributed to Cymru Country Produce Limited's shareholder

HM Revenue & Customs ("HMRC")

Following my appointment I was advised that Cymru Country Produce Limited was dormant for corporation tax purposes, and other Companies had filed corporation tax returns to 31 December 2013 My firm's tax department were engaged to prepare the outstanding corporation tax returns to the date of liquidation. These were submitted to HMRC in August 2015, and the Inspector provided clearances that there were no outstanding matters, and no objections to the liquidations being closed in September 2015.

I am also required to obtain clearances from HMRC's Enforcement and Insolvency Service unit ("EIS") which was incorporated in December 2014. EIS deals with all claims on behalf of HMRC, in respect of corporation tax, VAT and PAYE, and has suffered a significant backlog since taking over this responsibility. I have encountered significant difficulties throughout the duration of the liquidations in receiving responses from EIS

I received clearances from EIS for seven of the Companies in September and October 2015, but despite repeated chaser letters did not receive their reply in respect of the remaining four Companies until early April 2016. They provided clearances for two of the Companies. They also confirmed that four of the Companies had been part of a group VAT registration and had been removed from the group with effect of the date of liquidation

However, in respect of Favor Parker Limited, there is an outstanding liability of some, £2,266.85 in relation to PAYE/NIC and interest from 2008 to 2015. My tax team are investigating this as in 2014 and 2015 the Company did not have any employees

With regard to VION Subco MD Limited, EIS have advised that it appears there is an ongoing PAYE scheme in operation. Again, the Company has no employees and my tax department are taking steps to close the scheme.

Once the two outstanding points above have been dealt with I will seek clearances again from EIS.

Pension Schemes

I am obliged to submit a Section 120 notice to the Pension Protection Fund ("the PPF") for every liquidation following my appointment. Initial searches revealed that seven of the Companies may have connections to schemes.

The PPF have subsequently confirmed that the Companies are ineligible for the PPF assessment period as they are in members' voluntary liquidation, and that the PPF is not a creditor of the Companies.



Liquidator's Remuneration

Pursuant to the Insolvency Rules 1986, the Liquidator is obliged to fix his remuneration in accordance with Rule 4 148A(2) of the Insolvency Rules 1986. This permits remuneration to be fixed either:

- (1) as a percentage of the assets realised and distributed; and/or
- (2) by reference to the time the Liquidator and the staff have spent attending to matters in the liquidation, and/or
- (3) as a set amount; and/or
- (4) as a combination of the above

My remuneration was approved on a time costs basis on the date of my appointment. Time costs to date total £13,650 15 represented by 32.7 hours of work carried out by myself and my staff at an average hourly rate of £417 44 as detailed by the enclosed time costs summaries. Please note that further costs will be incurred to the closure of the liquidations

As agreed with the ultimate shareholder of the Companies, the costs of the liquidations will be paid by an appropriate associated company as none of the Companies holds any funds.

My staff and I have spent time on matters arising in the normal course of the liquidations. The main areas dealt with include:

- liaising with the Companies in relation to matters prior to the Liquidator's appointment,
- statutory reporting requirements to members,
- statutory reporting requirements to the Registrar of Companies;
- dealing with statutory advertising requirements,
- liaising with the Companies and VION to arrange submission of corporation tax returns for the pre-liquidation periods;
- correspondence with HMRC in order to obtain the necessary clearances to close the liquidations;
- corresponding with VION and providing updates of the progress of the liquidations, and
- convening the final meetings of members and preparing the distributions to members

Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. The sum of £2,753.99 has been incurred in respect of category 1 disbursements for statutory advertising costs and the costs of the indemnity bonding. Further advertising costs will be incurred when the final meetings of members of the Companies are convened

Members' rights

I provide at the end of this report an extract from the Insolvency Rules 1986 setting out the rights of members to request further information and/or challenge the remuneration or expenses within the liquidations.

Liquidation Closure

With the exception of Favor Parker Limited and VION Subco MD Limited, all matters in the liquidations have now been completed and, as agreed with VION, I am therefore in a position to



convene final meetings of the shareholders of the remaining nine Companies, notice of which is given below

Notice is hereby given pursuant to Section 94 of the Insolvency Act 1986 that meetings of shareholders will be held concurrently at these offices on 31 May 2016 at 10 00 hrs for the purpose of having accounts laid before the meetings and to receive the Liquidator's report showing how the winding-up of the Companies has been conducted, and of hearing any explanations that might be given by the Liquidator Forms of general/special proxy are attached should these be required. The meetings are purely formal and a report similar to that outlined above will be provided at the meetings.

Please note that the final meetings of members for Favor Parker Limited and VION Subco MD Limited will be convened when remaining tax clearances have been obtained.

Statement from the Insolvency Rules 1986 (as amended) regarding the rights of members in respect of the Liquidators' fees and expenses:

Rule 4.49E Creditors' and members' request for further information

- (1) If-
- (a) within the period mentioned in paragraph (2)—
 - (1) a secured creditor, or
 - (11) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question), or
 - (111) members of the company in a members voluntary winding up with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company, or
- (b) with the permission of the court upon an application made within the period mentioned in paragraph (2)-
 - (1) any unsecured creditor, or
 - (11) any member of the company in a members voluntary winding up,

makes a request in writing to the liquidator for further information about remuneration or expenses set out in a progress report in accordance with Rule 4 49B(1)(e) or (f) (including by virtue of Rule 4 49C(5)) or in a draft report under Rule 4 49D, the liquidator must, within 14 days of receipt of the request, comply with paragraph (3) except to the extent that the request is in respect of matter[s] in a draft report under Rule 4 49D or a progress report required by Rule 4 108 which (in either case) was previously included in a progress report not required by Rule 4 108

- (2) The period referred to in paragraph (1)(a) and (b) is-
 - (a) 7 business days of receipt (by the last of them in the case of an application by more than one member) of the progress report where it is required by Rule 4 108, and
 - (b) 21 days of receipt (by the last of them in the case of an application by more than one member) of the report or draft report in any other case
- (3) The liquidator complies with this paragraph by either-
 - (a) providing all of the information asked for, or
 - (b) so far as the liquidator considers that-
 - (1) the time or cost of preparation of the information would be excessive, or
 - disclosure of the information would be prejudicial to the conduct of the liquidation or might reasonably be expected to lead to violence against any person, or
 - (iii) the liquidator is subject to an obligation of confidentiality in respect of the information, giving reasons for not providing all of the information

Rule 4.148C Members' claim that remuneration is excessive

- (1) Members of the company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company, or any member with the permission of the court, may apply to the court for one or more of the orders in paragraph (6) on the grounds that—
 - (a) the remuneration charged by the liquidator,



- (b) the basis fixed for the liquidator's remuneration under Rule 4 148A, or
- (c) expenses incurred by the liquidator,

is or are, in all the circumstances, excessive or, in the case of an application under sub-paragraph (b), inappropriate

- (2) Application must, subject to any order of the court under Rule 4 49E(5), be made no later than 8 weeks (or 4 weeks when the liquidator has resigned in accordance with Rule 4 142) after receipt by the applicant of the report or account which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report")
- (3) The court may, if it thinks that no sufficient cause is shown for a reduction, dismiss the application, but it must not do so unless the applicant has had the opportunity to attend the court for a hearing of which the applicant has been given at least 5 business days' notice but which is without notice to any other party
- (4) If the application is not dismissed under paragraph (3), the court must fix a venue for it to be heard and give notice to the applicant accordingly
- (5) The applicant must at least 14 days before the hearing send to the liquidator a notice stating the venue and accompanied by a copy of the application and of any evidence which the applicant intends to adduce in support of it
- (6) If the court considers the application to be well-founded, it must make one or more of the following orders—
 - (a) an order reducing the amount of remuneration which the liquidator was entitled to charge,
 - (b) an order fixing the basis of remuneration at a reduced rate or amount;
 - (c) an order changing the basis of remuneration,
 - an order that some or all of the remuneration or expenses in question be treated as not being expenses of the liquidation,
 - (e) an order that the liquidator or the liquidator's personal representative pay to the company the amount of the excess of remuneration or expenses or such part of the excess as the court may specify.

and may make any other order that it thinks just, but an order under sub-paragraph (b) or (c) may be made only in respect of periods after the period covered by the relevant report

(7) Unless the court orders otherwise, the costs of the application must be paid by the applicant and are not payable as an expense of the liquidation
