  - To sell, lease, let, mortgage or otherwise dispose of the lands, houses, buildings, and other property of this company.
  - To advance money to any person or persons or corporation either at interest or without, upon the security of freehold (including enfranchised copyhold) or leasehold property by way of mortgage, or upon marketable security and in particular to advance money to shareholders in this company, and others, upon the recurity of or for the purpose of enabling the person borrowing the same to erect, or purchase or enlarge or repair any house or building, or to purchase the fee simple or any loss estate or interest in, or to take a demise for any term or terms of years of any freehold (including enfragehised copyhild) for leasehold property upon such terms and donditions assignish company may think fit.

(c) By deleting the penultimate paragraph of Clause 3 "Provided that the objects ..... and construed accordingly".
