### **INTRODUCTION**

The Company was placed into members' voluntary liquidation on 30 January 2019 when Emma Cray and David Matthew Hammond were appointed joint liquidators (the liquidators).

We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 30 January 2019 to 25 July 2019 and also serves as a progress report 30 January 2019 to 25 July 2019.

We are also required to give you certain information about the Company and the liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

### **REPORT ON THE LIQUIDATION**

#### **Realisation of assets:**

The directors' Declaration of Solvency showed that the Company's assets were:

After our appointment, the Company's inter group debt was taken under control until distribution.

Realisations from the Company's assets are as detailed in the above summary and totalled £1.

No additional assets have been identified. There are no assets still to be realised.

#### **Settlement of liabilities:**

This section covers all liabilities except any claims of HM Revenue & Customs (HMRC) which are dealt with separately below under HMRC.

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No claims were received in response to our notice and there are no outstanding claims to be agreed or settled.

#### **HMRC:**

The directors' Declaration of Solvency and the Company's records showed that the Company had no tax liabilities.

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities.

All matters have now been cleared and HMRC have confirmed their agreement to us closing the liquidation.

### Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of 400,000 £1 Ordinary shares.

On 27 March 2019, we made a distribution in specie of £1 (representing 0.0000025 pence per share) to the shareholder.

The distribution in specie consisted of an inter-group debtor balance together with any other assets held by the Company. The value attributed to the in specie distribution was based on the value held at which the asset was held in the Company’s books.

### OUR FEES AND EXPENSES

#### Basis of remuneration:

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

#### Funding of the liquidation:

Although fees have been paid to us on the basis specified above, our fees and expenses have not been paid out of the liquidation estate. Instead, Thames Water Utilities Limited has met our fees and expenses for the Company and 5 connected companies.

#### Remuneration charged:

Our fees for undertaking this assignment consist of time costs incurred for the period covering the formal liquidation. Our time costs for the period and agreed costs to close are:

The above time costs for the liquidation period are calculated to 12 July 2019, being the latest practicable date. This represents 76.30 hours at an approximate average hourly rate of £360.

Our fees for undertaking this assignment consist of time costs incurred in connection with this company and 5 connected companies for the period covering the formal liquidation. To date we have billed £21,664 in relation to our time costs and £693 of category 1 expenses in connection with the Companies, the invoices to date have been settled by Thames Water Utilities Limited.

#### Liquidators’ expenses:

During the liquidation we have incurred expenses of £693 plus VAT. These costs, which will be or have been re-charged, consist of:
