**REPORT TO THE CREDITORS PURSUANT TO SECTION 48 OF THE INSOLVENCY ACT 1986**

**1 Introduction**

Alan Robert Bloom and I were appointed as Joint Administrative Receivers of the above Company on 30 March 2000. I have compiled this report to creditors in accordance with Section 48 of the Insolvency Act 1986. Please note the change of name from HambroFraserSmith Limited to Professional Asset Management Limited was effected on 29 March 2000.

**2 Statutory information**

I attach Appendix I which provides statutory information for the Company.

**3 History of the Company**

The Company was incorporated in 1986 to provide professional and financial advisory services to clients introduced by other professional firms such as Solicitors and Accountants.

The company was acquired in October 1997 by its then management and a process of expansion commenced coupled with a concentration on building long term recurring income and fees. In December 1998 and April 1999 investments in the company were made by Rupert Hambro and certain associates and related Companies. In consideration for their investment, Rupert Hambro & Partners took up positions on the Board of Directors.

Minor acquisitions were made (Byas Mosley in June 1999) but the expected large scale acquisitions did not materialise.

#### **5 Events leading up to the appointment of the Joint Administrative Receivers**

5.1 The Company was experiencing mounting financial difficulties throughout 1999, partly due to poor trading results and also due to the contingent liabilities in respect of the SIB Pensions Review. As this financial situation was not improving, it was agreed by the Board at the end of September 1999 to seek a purchaser for the business. Over the following 6 months, several potential purchasers were identified and approached and negotiations with a number of them commenced. Towry Law plc emerged as the most likely purchaser and in February and March 2000 it conducted extensive due diligence. Negotiations reached a standstill as a result of the inability to cap the liabilities under the SIB Pensions Review.

##### **5.2 Sale of the business**

With the assistance of the Company's management and its advisors, negotiations recommenced and a sale of the business and certain assets of the Company was formulated with Towry Law plc in the days leading up to the receivership. Due to Personal Investment Authority (PIA) requirements, it was necessary to hive down the business and assets of the Company to a subsidiary, Fraser Smith Limited (originally known as Professional Asset Management Limited). The Company and its subsidiary both had changes of name registered at Companies House on 29 March 2000. Immediately on the receivership of the company on 30 March 2000, the shares in Fraser Smith Limited were sold to Towry Law plc for £1 million. The new company, Fraser Smith Limited, has since changed its name to Towry Law Fraser Smith Limited.

## **6 Conduct of the receivership**

### **6.1 Sale of the business**

As detailed in section 5.2 above, the sale of the business and assets of the Company was achieved on 30 March 2000. The liabilities of the Company, including any contingent liabilities under the SIB Pension Review, remain with the Company in receivership to be dealt with by any subsequent liquidator. As a condition of the sale, the Company, in receivership, was contracted to pay the March employee salaries.

### **6.2 Pre-Receipt Book Debts**

The book and other debts of the Company as at 30 March 2000 were excluded from the sale of assets to Towry Law plc. As part of the agreement with the purchaser it has been agreed that Towry Law Fraser Smith Limited will collect the book debts and account to the Receivers for any receipts within 28 days. The book value of all these debts is approximately £900,000 although on review by our staff we have estimated that only £400,000 will be collectable.

Included in the above total are amounts in respect of prepayments and sundry debts. In accordance with the Agreement with Towry Law plc, the value in prepayments as at 30 March 2000 will be reimbursed to the Company. Prepayments consist of rents and leasing charges paid in advance and also various deposits.

Further value was added by identifying during pre appointment investigations the existence of 'Pipeline' debtors. These related to commissions on policies which had been submitted to insurers for approval and acceptance. Until such time as the insurers approve the policies the commissions are not taken into book debts. The value of 'Pipeline' at 30 March 2000 was approximately £290,000. As this was not included in the work in progress or debtors it was agreed to share the Pipeline as at 30 March 2000 on a 50:50 basis with Towry Law plc.

## **7 Amounts due to secured creditor**

At the date of our appointment, £414,724 was due to Lloyds TSB Bank Plc under a fixed and floating charge over the assets of the Company. I anticipate being in a position to repay the Bank's indebtedness in full.

**8 Statutory Statement of Affairs**

I enclose a copy of the Directors' Statement of Affairs at Appendix II as required to be furnished to me pursuant to Section 47 of the Insolvency Act 1986.

**9 Preferential creditors**

The following are estimated amounts due to the preferential creditors:-

Whilst the above amounts have yet to be agreed, at this stage, I anticipate making a dividend of 100p in the £ to preferential creditors.

**10 Unsecured creditors**

There is likely to be a dividend to unsecured creditors in the subsequent liquidation of the company. The amount of any potential dividend to unsecured creditors is currently unclear pending resolution of various outstanding issues and cost provisions.


**11 Receipts and payments**


