The Directors submit their Report and the accounts of the Company for the year to 30 June 2018.

Activities of the company

The Company was formed to acquire the freehold title to the land forming part of the Deansbrook development in Burnt Oak, Edgware, in the London Borough of Barnet, to grant leases of the 54 flats thereon and to manage, administer and maintain the land, buildings and property forming part of the development, which is the Company's main activity. Results
