The directors continually assess the performance of the company and the financing structure of the entity

### **Going Concern**

The directors have a reasonable expectation that the company has adequate resources or will receive the necessary support from its parent to continue in operational existence for the foreseeable future Accordingly, the directors continue to adopt the going concern basis in preparing the report and the financial statements

#### 1. Accounting policies

#### **Accounting convention**

The financial statements are prepared in accordance with applicable United Kingdom accounting standards, under the historical cost convention and on a going concern basis

#### Foreign currencies

The company's functional currency is US dollar Transactions denominated in other foreign currencies are translated into US Dollars and recorded at the rate of exchange ruling at the date of the transactions Balances denominated in other currencies, including forward foreign exchange commitments, are translated in to US Dollars at rated ruling at the balance sheet date and the gains and losses on translation arising are included in the profit and loss account

#### Cash flow statement

In accordance with Financial Reporting Standard 1 (revised), EDS Finance Limited has not published a cash flow statement as its ultimate parent company, Hewlett-Packard Company, which is incorporated in the United States of America, has published consolidated financial statements in which the cash flows of the company are included

#### **Taxation**

The charge/(credit) for taxation is based on the profit/(loss) for the year/period and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes

Deferred tax is recognised without discounting in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in future or a right to pay less tax in future have occurred at the balance sheet date. Timing differences are differences between the company's taxable profits and its results as stated in the financial statements that arise from the inclusion of gains and losses in taxable profits in periods different from those in which they are recognised in the financial statements

A net deferred tax asset is regarded as recoverable and therefore recognised only when, on the basis of all available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted

### c) Factors affecting tax charge

Tax losses of \$798k (2011 \$12,868k) have been carried forward. Due to the uncertainty of future profits no deferred tax asset has been recognised on these

The Finance Bill 2012 included a reduction in the UK corporation tax rate from 26% to 24% from 1 April 2012 and a further reduction to 23% from 1 April 2013. These rates were enacted on 17 July 2012 and therefore deferred tax assets and liabilities as at 31 October 2012 have been calculated at a rate of 23%.

### 6. Taxation on ordinary activities (continued)

In his Autumn Statement of 5 December 2012, the Chancellor of the Exchequer announced Budget tax changes, which, if enacted in the proposed manner, will have an effect on the company's future tax position. The Budget proposed a decrease in the rate of UK corporation tax in addition to the reduction to 22%, by a further 1%, to 21% as of 1 April 2014. Furthermore, in his budget on 21 March 2013, the Chancellor of the Exchequer announced a further reduction to the UK Corporation Tax rate by 1% from 1 April 2015, to 20%.

The effect on the Company of these proposed changes to the UK tax system will be reflected in the Company's financial statements in future years, as appropriate, once the proposals have been substantially enacted
