**IT IS ORDERED THAT:**

- 32 The office-holders named in Schedules 1A to 1J be appointed as Joint Liquidators of those companies listed in Schedules 1A to 1J in the event that those administrations convert to Creditors' Voluntary Liquidations.
- 33 In the case of each the companies or individuals identified in the Schedules the office-holder appointed or continuing in office (as identified in those Schedules) will cause notice of the change in office-holders:
- (a) to be given to the Secretary of State for Business, Energy and Industrial Strategy within 14 days of the date of this order;
  - (b) to be given to the Financial Conduct Authority, as regards the company and Individuals listed in Schedules 6Y and 6Z, within 14 days of the date of this order;
  - (c) to be given to the creditors by way of advertisement in the Gazette within 14 days of the date of this order, such advertisement to include a notice that any creditor may within 28 days of the advertisement of the order make an application to Court to set aside or vary the terms of the order. Such application shall not affect the transfer of the cases listed in the Schedules until further or other order by the Court; and
  - (d) to be included in their next written report to the creditors of the estates of the cases listed in the Schedules.
- 34 Pursuant to paragraph 98(2)(c) of Schedule B1 of the Act, Neil David Gostelow and Stephen John Absolom shall be discharged from liability in respect of their actions as Joint Administrators of the companies listed in Schedules 1A to 1J:
- (a) if no application is made pursuant to paragraph 40 below, on the date being 28 days from the date of the advertisement referred to in paragraph 33(c) above; or
  - (b) if an application is made pursuant to paragraph 40 below, at such time as should be subsequently ordered by the Court.
- 35 Pursuant to s173(2)(b) of the Act, Neil David Gostelow and Stephen John Absolom shall receive their release as Joint Liquidators of the companies (creditors voluntary liquidation) listed in Schedules 2A to 2J and the companies (members voluntary liquidation) listed in Schedules 4A to 4D 28 days from the date of the advertisement referred to in paragraph 33(c), save that such release may be subject to further order in the event of an application by any creditor under paragraph 40 of this order for the specific case subject to that application.
- 36 Pursuant to s174(2)(b) of the Act, Neil David Gostelow and Stephen John Absolom shall receive their release as Joint Liquidators of the companies (in compulsory liquidation) listed in Schedules 3A to 3C and the companies (members voluntary liquidation) listed in Schedules 4A to 4D 28 days from the date of the advertisement referred to in paragraph 33(c), save that such release may be subject to further order in the event of an application by any creditor under paragraph 40 of this order for the specific case subject to that application.
- 37 Neil David Gostelow be discharged from liability in respect of his actions as Trustee in Bankruptcy of the individuals listed in Schedule 5A to 5B at such time as the Secretary of State

may determine following an application made by Neil David Gostelow to the Secretary of State in accordance with section 299(3)(b)(ii) of Insolvency Act 1986.

- 38 Where in any matter an officeholder is as a consequence of this order appointed jointly with another, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
- 39 The Applicants to serve the Application upon the Respondents by email to each of the Respondent's nominated email address.
- 40 There be liberty for each creditor of the companies listed in the Schedules to apply to vary or discharge this order in so far as it relates to a company of which that person is a creditor within 28 days of the publication of an advertisement in relation to that company in accordance with paragraph 33(c) above.
- 41 There be no order as to costs.
- 42 Such further order or relief as the Court shall deem fit.
- 43 The Applicants have permission to apply.
