



**1. Accounting policies**

**1.1. Accounting convention**

The accounts are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective March 2000).

**1.2. Turnover**

*Turnover represents the total invoice value, excluding value added tax, of sales made during the year.*

**1.3. Leasing**

Rentals payable under operating leases are charged against income on a straight line basis over the lease term.
