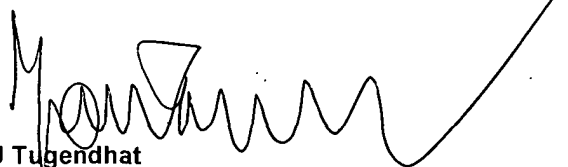
Each of the persons who are directors at the time when this directors' report is approved has confirmed that:

Independent auditor's report to the member of Kidsunlimited Limited

1 General Information

Kidsunlimited Limited is a company incorporated in England and Wales under the Companies Act 2006. The address of the registered office can be found on the Company Information page. The nature of the company's operations and its principal activities can be found in the Directors' Report.

2 Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the company's accounting policies (see note 3).

The following accounting policies have been applied:

2.3 Consolidated financial statements

The financial statements contain information about Kidsunlimited Limited as an individual company and do not contain consolidated financial information as the parent of a group. The company has taken advantage of the exemption conferred by the Companies Act 2006 not to produce consolidated financial statements as it is included in EEA group accounts of a larger group.

2.4 Financial liabilities and equity
