- The liquidator be authorised to distribute all or part of the assets of the company in specie to the shareholders in such proportion as they mutually agree and that the liquidator be authorised under the provisions of Section 165 (2) (a) of the Insolvency Act 1986 to exercise the powers laid down in Schedule 4, Part 1 of the Insolvency Act 1986
- The Company's articles be amended by inserting the following "If the Company is wound up, the liquidator may, with the sanction of a special resolution of the Company and any other sanction required by the Act, divide among the members in specie the whole or any part of the assets of the Company, including any shares, and may for that purpose, value any assets and determine how the division shall be carried out as between the members or different classes of members. The liquidator may with the like sanction, vest the whole or any part of the assets including shares, in trustees upon such trusts for the benefit of the members as he with the like sanction determines, but no member shall be compelled to accept any assets upon which there is a liability."
