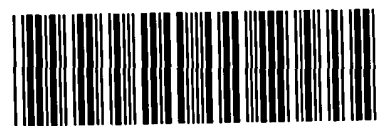

**1. Accounting policies**

**1.1 Basis of preparation of financial statements**

James Pringle Llanfairpwllgwyngyllgogerychwyrndrobwlillantysiliogogoch Woollen Mill Limited (the "Company") is a private company incorporated, domiciled and registered in the UK.
