

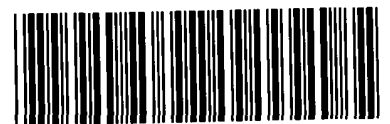

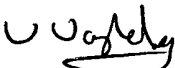
- select suitable accounting policies and then apply them consistently;

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Adoption of FRS101

In the current period the Company has adopted Financial Reporting Standard 101 "Reduced Disclosure Framework" ("FRS 101"). In previous periods the financial statements were prepared according to applicable UK accounting standards. There has been no material adjustments made to these statutory financial statements regarding the transition to FRS 101. 1. Accounting policies
