Proposals deemed accepted on 11 May 2010:

The Joint Administrators propose that they

- a) they continue to realise assets in accordance with objectives 2 and 3 of the statutory purposes of the Administration, and
- b) they make payments to the secured creditor and make a distribution to the unsecured creditors from the Prescribed Part via a Court Application (where applicable), and
- c) (1) they exit the Administration by way of dissolution, or, if the Administration is not complete within 12 months,
