The company has not traded during the year and the directors do not expect the company to trade in the forthcoming year.

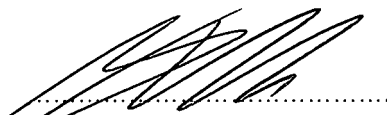

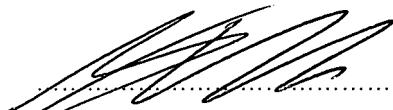
