The scope of our work for the purposes of this report does not include examining or dealing with events after the date of our report on the full financial statements.

#### Opinion

In our opinion the company is entitled under sections 246 and 247 of the Companies Act 1985 to the exemptions conferred by Section A of Part III of Schedule 8 to that Act, in respect of the year ended 31 October 1995, and the abbreviated accounts on pages 4 to 7 have been properly prepared in accordance with that Schedule.

#### Other information

On 29 August 1996 we reported, as auditors of Astral Communications and Electronics Limited, to the members on the financial statements prepared under Section 226 of the Companies Act 1985 for the year ended 31 October 1995 and our audit report is reproduced on pages 2 to 3 of these abbreviated accounts.

#### (Reproduced from the full financial statements)

We have audited the financial statements on pages 5 to 12 which have been prepared under the historical cost convention and the accounting policies set out on page 7.

#### Respective responsibilities of directors and auditors

As described on page 1 the company's directors are responsible for the preparation of financial statements. It is our responsibility to form an independent opinion, based on our audit, on those statements and to report our opinion to you.

#### Basis of opinion

We conducted our audit in accordance with Auditing Standards issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgements made by the directors in the preparation of the financial statements, and of whether the accounting policies are appropriate to the company's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. However, the evidence available to us was limited because the directors have been unable to provide any documentation to support the figure for stock included in the balance sheet at £35,546 as at 31 October 1995 and £20,000 as at 31 October 1994. Any adjustment to these figures would have a consequential significant effect on the profit for both the year ended 31 October 1995 and the year ended 31 October 1994.

In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.

#### Opinion: Disclaimer on view given by financial statements

Because of the possible effects of the limitation of evidence available to us, we are unable to form an opinion as to whether the financial statements give a true and fair view of the state of the company's affairs as at 31 October 1995 or as at 31 October 1994, or of its profit for either the year ended 31 October 1995 or the year ended 31 October 1994. In all other respects, in our opinion the financial statements have been properly prepared in accordance with the provisions of the Companies Act 1985 applicable to small companies.

ASTRAL COMMUNICATIONS AND ELECTRONICS LIMITED NOTES TO THE ABBREVIATED STATUTORY ACCOUNTS FOR THE YEAR ENDED 31 OCTOBER 1995

#### 1. ACCOUNTING POLICIES

a. These financial statements are prepared under the historical cost convention and include the results of the company's operations which are described in the Directors' Report and all of which are continuing.

The company has taken advantage of the exemption in Financial Reporting Standard No. 1 from the requirement to produce a cash flow statement on the grounds that it is a small company.

b. Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their estimated useful lives on the following bases:

Equipment 25% per annum on net book value Fixtures and fittings 15% per annum on net book value Motor vehicles 25% per annum on net book value

- c. Assets being acquired under hire purchase contracts and finance leases are capitalised at their fair value and written down to their estimated residual value over their estimated useful life in accordance with the company's policy for tangible fixed assets. The interest portions of the instalments are charged to the profit and loss account in the periods in which they fall due.
- d. Rentals on operating leases are charged to the profit and loss account in the periods in which they fall due.
- e. Stocks are valued at the lower of cost and net realisable value after making due allowance for slow moving and obsolete items.
- f. Provision is made at current rates for taxation deferred in respect of material timing differences, except to the extent that, in the opinion of the directors, there is reasonable probability that the liability will not crystalise in the foreseeable future.
- g. The company operates a defined contribution pension scheme and the pension charge represents the amounts payable by the company to the fund in respect of the year.

Included within debtors is an amount of £19,070 (1994: fnil) due from Astral Communications (Wakefield) Limited, a company in which S Atherton is the controlling shareholder.

#### 4. CREDITORS

Creditors at 31 October 1995 include hire purchase creditors of £23,074 (1994: fnil) which are secured on the assets being acquired under the agreements.
