1 Introduction and Statutory Matters

- 1 1 Simon Granger, Chad Griffin and Simon Kirkhope ("the Administrators") of FTI Consulting LLP ("FTI") were appointed as Joint Administrators of 2e2 UK, Holdings, Investments, 2e2 Group, 2e2 Ltd, Managed Ops, MOH, Property, MGL, DQL ("the Initial Entities") on 28 January 2013
- 1 2 The Administrators were appointed over the Initial Entities following applications to the High Court of Justice, Chancery Division, Companies Court ("the Court"), by the directors of the Initial Entities in accordance with Paragraph 22, Schedule B1 of the Insolvency Act 1986, as amended ("the Act")
- 1 3 On 15 February 2013, the Administrators were appointed as Joint Administrators of MS, Diagonal and Morse. The Administrators were appointed following applications to the Court by the holders of Qualifying Floating Charges in accordance with Paragraph 14 of Schedule B1 of the Act
- 1 4 Simon Granger is licensed in the United Kingdom to act as an insolvency practitioner by the Association of Chartered Certified Accountants under section 390(2)(a) of the Act. Chad Griffin and Simon Kirkhope are licensed in the United Kingdom to act as insolvency practitioners by the Institute of Chartered Accountants in England and Wales under section 390(2)(a) of the Act. Pursuant to Paragraph 100(2) of Schedule B1 to the Act the Administrators act jointly and severally so that all functions may be exercised by each and either of them
- 1 5 This Report and Statement of Proposals ("the Report") is prepared pursuant to Paragraph 49, Schedule B1 of the Act in relation to the Companies, the purpose of which is to provide creditors with an update as to the present position and future strategy of the Administrations to assist the creditors and enable them to decide on whether or not to vote for the Proposals. This Report also includes information required to be provided to creditors pursuant to Rule 2.33 of the Insolvency Rules 1986 (as amended) ("the Rules"). Statutory information pertaining to the Companies and as required by the Rules is set out in Appendix A
- 1 6 As we anticipate that there are insufficient funds available in each of the Companies for a distribution to unsecured creditors other than potentially a Prescribed Part ("PP") distribution (a fund set aside for the benefit of unsecured creditors by virtue of Section 176(A)(2)(a) of the Act), and in accordance with Paragraph 52(1) of Schedule B1 to the Act, the Administrators will not be convening a meeting of creditors unless required to do so
- 1 7 Should creditors whose total debts amount to at least 10% of the total debts of any of the Companies wish to request a meeting be held they should complete the attached form 2.21B and return it within 8 business days of the issue of this report. A deposit of £2,000 towards the cost of convening the meeting should be enclosed with the request per Rule 2.37(3) of the Rules
- 1 8 In the event that no request (in the prescribed manner) is received prior to the deadline above in respect of each of the Companies, the Proposals of each of the Companies will be deemed approved and a notice will be filed at Companies House
- 1 9 The centre of main interest of each of the Companies is the United Kingdom. Therefore, the EC Regulations on Insolvency Proceedings 2000 apply to the Administrations. The proceedings are main proceedings as defined by Article 3 of those regulations
- 1 10 In preparing this report, we have relied on information provided by the directors and management of the Companies and other third parties. Our investigations are continuing and accordingly, it has not been possible to verify all such information. Therefore, we take no responsibility for the accuracy and completeness of this information or otherwise

2 Background to the Group

- 2.1 The Group (i.e. 2e2 Holdings Limited and its direct and indirect subsidiaries) had grown through acquisition over a number of years leading to a relatively large group structure which is summarised at Appendix C. The Group's key UK trading entity was 2e2 UK.
- 2.2 The Group's core business was as an IT services provider providing a wide range of services including data centre services, flexible resource contracts, managed service contracts, professional services and programme support. Services were provided from a single, discrete technology implementation through to full IT outsourcing.
- 2.3 The UK business' largest customer was Telefonica O2, both in its own right and in relation to the O2 Unify contract. O2 Unify was a commercial joint venture between 2e2 UK Limited and Telefonica O2 which sought to consolidate customers' IT and telecommunications needs under a single management structure.
- 2.4 The Group also had international subsidiaries in Spain, the Netherlands, Channel Islands, Isle of Man, Ireland and the United States.
- 2.5 The Group had over 1,400 employees in the UK and c 500 in overseas subsidiaries.

Overview of Financial Information

- 2.6 Financial information for the Group is summarised below. This comprises extracts from the Group's consolidated unaudited draft accounts for the year ended 31 December 2012, audited accounts for the year ended 31 December 2011 and audited accounts for the year ended 31 December 2010. Please note this information has not been verified by the Administrators or FTI.
- 2.7 Consolidated turnover for the Group fell from £404m for the year ended 31 December 2011 to £337m in the year ended 31 December 2012.
- 2.8 The Group also experienced a reduction in profitability, with gross profit margin falling from 34.5% in FY2010 to 20.1% in FY2012.
- 2.9 Taking into account other expenses, exceptional items, tax and interest costs, the Group reported net losses in each of the last three years with the position worsening to a £48m net loss in FY2012.

- 2.10 The Group was financed by secured bank debt of c £113.2m held by a syndicate of five lenders (the "Senior Debt") and c £49.8m of mezzanine debt (the "Mezzanine Debt") held by five further lenders (collectively, "the Secured Creditors"). The Senior Debt and Mezzanine Debt are secured by debentures over substantially all of the Group's assets. The debt

predominantly relates to the financing of acquisitions together with working capital funding. The Group has further debts of £85m Payment in Kind ("PIK") notes ("£85m Notes"), and £9.2m PIK notes ("£9.2m Notes") (together the "PIK Notes"). The PIK Notes are secured over the assets of Investments. With the exception of Holdings, all of the other Group companies in administration have also granted security in respect of the PIK notes, which is subordinated to the Senior debt and mezzanine debt.

2.11 Over and above the Senior Debt, the Mezzanine Debt and the PIK notes, the Group also had a receivables financing arrangement.

2.12 The Group's equity investors were Hutton Collins and Duke Street.

3 Events Leading up to the Administrations

3.1 In December 2012, the Group notified the Secured Creditors that the Group may breach its December 2012 financial covenants and that it had appointed a Chief Restructuring Officer to support the Group with its discussions with stakeholders.

3.2 During January 2013 while the Secured Creditors prepared to review the financial position of the Company, the Group took steps to appoint an Interim Group Finance Director and Interim Chief Operating Officer to oversee the day to day financial and operational management of the business.

3.3 By mid-January 2013, the Group was facing a significant liquidity crisis, with an estimated funding requirement of an immediate £25m to the end of February 2013 and an aggregate amount of £45m to 20 April 2013. This funding requirement arose due to a combination of factors, but was principally driven by three key elements:

- I A prolonged deterioration in underlying profitability,
- II An unsustainable level of accumulated trade and other creditor liabilities (including several defaulted 'time to pay' arrangements with HMRC) and the loss of credit insurance, and
- III The Group's inability to finance further invoices through a receivables financing arrangement with Hutton Collins.

3.4 The Group held discussions with the Secured Creditors and Hutton Collins to determine whether funding could be obtained to avoid an imminent insolvency. However, the scale of the new money requirement was significant and the Secured Lenders had little visibility into the underlying reasons for the Group's deteriorating financial position.

3.5 On Thursday 24 January 2013 the Group presented an updated view of the Draft 2012 Financial Results to the Secured Lenders. Previous information provided to the Secured Lenders had indicated Earnings Before interest Tax, Depreciation & Amortisation ("EBITDA") as at November 2012 to be £27.3m and a full year outlook of £34.6m. However, the 24 January presentation reported that 'significant weaknesses in financial reporting and process have been identified', which has given rise to a number of accounting adjustments. As a result of these adjustments, full year EBITDA for 2012 was revised downwards from £34.6m to £11.6m, before taking into account exceptional costs of a further £20m.

3.6 In view of the revised information regarding the financial position of the business, and the quantum of the new money requirement, the Secured Creditors were not in a position to lend further monies to the Group and notified the directors of this fact on Friday 25 January 2013.

3.7 With the Group unable to secure additional funding from Secured Lenders or other stakeholders, the directors had no option other than to take steps to place the Companies into Administration.

- 3 8 Contingency planning for administration of the Initial Entities took place in a highly compressed timescale and largely over the weekend of 26 and 27 January
- 3 9 On Monday 28 January 2013, the directors applied to the High Court to appoint administrators in relation to the Initial Entities and the appointments were confirmed at approximately 4 30pm on the same day
- 3 10 On 15 February 2013, the Administrators were appointed as Joint Administrators of MS, Diagonal and Morse as it had been identified that these entities held assets which would be required to be sold as part of the sale of businesses

4 Objective of Administrations

4 1 Administrators must perform their functions with the purpose of achieving one of the following statutory objectives

- rescuing the company as a going concern,
- achieving a better result for the company's creditors as a whole than would be likely if the company was wound up, or
- realising property in order to make a distribution to one or more secured or preferential creditors

4 2 The Group had significant unsecured and secured liabilities, and the first objective would not have been achievable without restructuring these creditors, which we did not believe was possible given the loss making position of the Group and impact of the Administration on its businesses

4 3 We considered the options available and concluded that the purpose of each of the Administrations would be to achieve a better result for the Companies' creditors as a whole than would be likely if the Companies were wound up without first being placed into administration

4 4 In order to seek to achieve this we continued to trade the business of the UK entities within the Group, whilst offering the business for sale We considered that this would maximise realisations for the Group's creditors

4 5 Our strategy was to also allow the international businesses held by the Group to continue to trade outside of any insolvency process, which would in turn allow a structured share sale process to take place, with the aim of maximising realisations for the benefit of creditors

4 6 Further details on the implementation of the Administration objectives are included below

5 Administration Strategy – UK Business

5 1 The overriding strategy for the UK was to seek to continue to operate the business so far as was possible whilst an accelerated sales process was undertaken Given the critical condition of the Companies' finances at the time the Administrators were appointed, the Administrators entered into a funding agreement with Royal Bank of Canada, in order to enable critical payments to be made while a buyer was sought

5 2 We were aware that certain of the Group's UK business offerings could not be traded profitably in administration and others would only be capable of being continued for a short period of time in administration due to commercial pressures

The initial customer strategy therefore focused on

- Flexible Resourcing contracts (where 2e2 staff and contractors were embedded in customer organisations) and where payment undertakings were sought to cover the January payroll payment,
 - critical contracts, covering areas such as financial systems, defence and NHS projects and critical infrastructure,
 - maintaining the Data Centre Operations, and
 - maintaining the profitable or valuable contracts where value could be realised
- 5 3 The IT hardware and software supply business was ceased immediately on appointment as there was no capacity to source inventory from suppliers and customers were unwilling to purchase capital goods from an insolvent company
- 5 4 Accordingly, we ceased business activities in certain areas and sought a very accelerated sale of the whole of the remaining business. As a result of the financial position of the Group, and the cessation of certain business activities 345 employees were made redundant within the first week of the Administration.
- 5 5 A number of customers terminated contracts shortly after administration. These were primarily where services were easy to migrate to alternative providers or staff could be taken in-house (such as flexible resourcing contracts and support contracts)
- 5 6 During the week ended 1 February 2013 the Administrators received expressions of interest in the UK business and assets from around 70 interested parties. This list was narrowed down to a small number of parties who provided the best prospect of concluding an acceptable acquisition of the business within a very short time period. These buyers undertook extensive due diligence in a highly accelerated time frame in order to fully evaluate the profit potential of the business and the potential costs and liabilities relating to the transaction.
- 5 7 Regrettably, by 5 February 2013, all of these parties had been unable to deliver an offer acceptable to the Administrators, as they were ultimately unable to get comfortable on the ability of the businesses to retain key customers. Furthermore, bidders were unable to satisfy themselves in relation to certain liabilities of the Companies.
- 5 8 With the sale of the whole of the UK business no longer possible, the Administrators were required to close substantial parts of the UK business, resulting in the redundancy of 627 employees.
- 5 9 On 7 February, we completed a transaction whereby O2 Redwood Limited, a subsidiary of Telefonica UK Limited, bought the O2 Unify part of the business for total consideration of £4.0m. As a result, the employment of 107 staff automatically transferred to O2 Redwood Limited with effect from 7 February 2013 pursuant to the Transfer of Undertakings (Protection of Employment) Regulations 2006 (TUPE).
- 5 10 Further redundancies were made on 8 February 2013 such that the only material business activity on-going comprised the Data Centres.
- 5 11 Following withdrawal of interested parties for the business as a whole, we undertook a further marketing exercise of the Data Centres based at Reading, Gateshead and a third party site at Newcastle upon Tyne. £0.8m of funding was obtained from Data Centre customers to allow continuation of trading for a further period while this sales process was completed.
- 5 12 This sale process resulted in two interested parties being at a relatively advanced stage on 13/14 February. A transaction to sell the Data Centres to Daisy Data Centre Solutions Limited

(an Oakley SPV managed by Daisy Group) completed on 15 February 2013 for total consideration of £2.8m. Completion of the Data Centre sale avoided a potential 4 to 6 month managed wind-down process to return customer data in an orderly manner and resulted in the TUPE transfer of 153 employees.

- 5.13 Some of the key activities since the completion of the Data Centre transaction include realisation of other assets, book debt collections, dealing with stock and retention of title claims, employee matters, site closures and property matters, which are discussed in further detail later within this report.

6 Administration Strategy – Overseas Business

European Businesses

- 6.1 The Group's European subsidiaries were largely autonomous from the UK group. We worked with the subsidiary boards to provide support and where needed engaged with key local customers and suppliers, together with local management. Where linkages with the UK business were identified (e.g. email systems) steps were taken to ensure they were completely standalone within a week of the commencement of the administrations of the Initial Entities.
- 6.2 The short term cash flows indicated that there was sufficient liquidity available to run an orderly disposal process over a 3 – 4 week period, with the exception of the Isle of Man subsidiary. Provisional liquidators were appointed to the Isle of Man subsidiary and a sale of the subsidiary occurred preserving all the jobs. However, value realised from this transaction flowed to the Secured Creditors rather than the Group given local security was in place.
- 6.3 The disposal process for the remaining European subsidiaries (in Spain, Ireland, Channel Islands and the Netherlands) was commenced immediately upon appointment and 78 parties were contacted. 35 parties signed confidentiality agreements and were admitted to a data room. Certain potential buyers attended management meetings during the week prior to the bid deadline of 11 February. By 11 February, 19 offers had been received.
- 6.4 Logicalis bid €24m in total for the Group's subsidiaries in Spain, Ireland, Channel Islands and Netherlands. This offer was the best bid received, based on overall value and deliverability of transaction as Logicalis was willing to acquire all of the European Businesses in one transaction and had limited due diligence requirements given that they were already well acquainted with the Group from previous discussions. We subsequently worked with Logicalis to progress due diligence, transaction structuring and documentation.
- 6.5 On 4 March, we completed the sale of 2e2's international companies in Spain, Ireland, Channel Islands and the Netherlands to Logicalis. This preserved all 480 jobs in the European subsidiaries. Total consideration achieved was €24m (£20.6m). However, an element of consideration is subject to escrow arrangements and therefore cash received to date is £18.6m.

US Business

- 6.6 On 15 February we concluded a sale of the Group's US subsidiary, Diagonal Consulting Inc, to G3, a competitor, for US\$250k following a discrete targeted sale process. Due to a number of factors, it was necessary to progress this sale quickly and with limited due diligence. The G3 offer was the highest bid received for this business and preserved all 17 jobs.

7 Other Asset Realisations

Wisdom

- 7.1 'Wisdom' is an integrated information management software solution comprising electronic records management and document capture.

7 2 Following a competitive sale process, on 27 February 2012 we completed on the sale of the Wisdom assets and IP to Daisy Data Centre Solutions Limited for £290k

7 3 The proceeds of sale were split equally between 2e2 UK and Diagonal and represent floating charge realisations into the Administration estates of these companies

Debtors

7 4 At the date of Administration of 2e2 UK, its debtor ledger totalled £43m To date, realisations have totalled £4 1m A number of factors have limited the recovery of book debts, including a significant number of invoices representing future billings for advanced periods for which 2e2 are unable to provide services

7 5 It appears that certain of the receivables balances may have been assigned to companies who provided third party financing We are currently reviewing these arrangements

7 6 We have appointed JP Associates, a firm of debt recovery specialists, as our agents to realise debts owing to the Companies JP Associates have experience in realising IT sector debts in insolvencies

Stock

7 7 On appointment 2e2 UK's stockholding (excluding spares stock) had a net book value of £0 8m This is low value due to the "bill and hold" system (see retention of title section of this report for further information) Due to this and the existence of retention of title claims, we do not expect any material recoveries from stock realisations

7 8 On appointment 2e2 UK's spares stock had a net book value of £1 6m This stock was not subject to retention of title claims as it was older repeat use stock This stock was sold through a competitive sale process for £90k The realisable value of the spares stock was low in comparison to book value as it was repaired pre-used stock held at multiple locations 14 interested parties were provided with the details of the stock and £90k was the highest offer received

Chattel Assets

7 9 Following the sale of assets located at the data centres we are working with our chattel agents, Wyles Hardy & Co to realise fixtures, fittings, office and IT equipment where such assets are not subject to lease

Other Assets

7 10 We are continuing to explore the sale of intellectual property assets held by the Group, together with a minority shareholding in a joint venture

8 Other Matters

Employees

8 1 As set out above in relation to the administration strategy for the UK business, due to limited funds and the fact that certain of the UK business could not be traded in administration it was unfortunately necessary to make 345 employees redundant in the first week of the administrations

8 2 Additional redundancies became necessary during the administrations as a result of customers cancelling contracts Unfortunately once a sale of the business as a whole was not possible a further 627 redundancies were made on 6 February 2013

8 3 We have worked together with retained key company staff to provide information to the purchasers of the business units discussed above and to assist with the transfer of employment of the 260 UK employees that transferred as a result of the sales discussed above to O2 Redwood Limited and Daisy Data Centre Solutions Limited Where other IT service providers have commenced the provision of services to former Group customers and

this has resulted in a transfer of undertakings, such information as has been requested has been provided to these service providers. To date we have been advised of 110 staff who have transferred under TUPE to replacement IT service providers

8 4 In addition, information has been provided to employees and to the Redundancy Payments Office to assist in the assessment and submission of employee claims against 2e2 UK and Holdings, in conjunction with our employment claims specialists, Payco

8 5 We have also dealt with a high volume of employee queries in relation to aspects of the insolvency process and to the impact of the Administrations on the benefits that were formerly afforded to company staff

Retention of Title

8 6 We have received notification of retention of title claims from 37 parties. The current status in relation to these claims is summarised below

- 17 have been resolved in full
- 3 are potential claims notified by trade insurers where no claim submission has been received from the supplier
- 5 claims received where there was no stock located at the Group's premises as it had been delivered to customers prior to the commencement of the Administration
- 12 claims received not yet resolved where stock is located at the Group's premises

8 7 The Group operated a "bill and hold" system on behalf of certain customers where stock was invoiced to the customer, but remained in either the Group's premises or facilities operated by the Group's logistics partners. As a result, the majority of retention of title claims involve both a supplier and a customer of the Group asserting title over the same batch of stock. We continue to seek to resolve the remaining claims as quickly as practicable given the complexities

Property

8 8 At the date of our appointment MS was the lessee on the lease for the Reading data centre property, whilst Managed Ops was the holder of a long lease over the Gateshead data centre property. The Group's interest in these property assets was sold to Daisy as part of the transaction discussed above

8 9 At the date of appointment entities within the Group were lessees on 30 leases (including the two discussed above). Six of these leases had been vacated prior to the date of our appointment, three were let to subtenants and 21 were occupied by Group

8 10 Since our appointment, in conjunction with our agents, we have secured all of these sites and sought to realise all assets of value held on site

8 11 To date, we have contacted the landlords to advise that 27 of these leases are no longer required for the purposes of the Administrations. Certain of the tenants of these leases are Group entities which are not in administration. Where the tenant is one of the Companies in administration we have written to the landlord to request a surrender of the lease. We intend to exit all leased properties in the near future as the business of the Group continues to be wound down

Other Creditors

8 12 As Administrators, we have a statutory duty to advertise for creditor claims. Any creditor who believes they may have a claim should submit their claim to us as soon as possible, using the statement of claim form attached at Appendix I, unless they have already done so. In addition, any creditor who has leased assets to the Group should contact the Administrators in order to assist with the recovery of any assets held by the Group

Taxation

8 13 We have undertaken initial corporation tax and VAT reviews. We will prepare the necessary tax returns to finalise the pre-appointment tax position, and will submit appropriate corporation tax, VAT and PAYE/NIC returns for the period of the Administrations.

Statutory Investigations

8 14 We have begun gathering data for our initial investigations work to comply with our statutory duties pursuant to the Company Directors Disqualification Act 1986. We are obliged to review the conduct of all directors who served in respect of the Companies in the 3 year period prior to the date of Administrations.

8 15 Should any creditors have any further relevant information in relation to directors' conduct, they should provide details in writing to the Administrators. This request forms part of our normal investigations into directors' conduct and does not imply any criticism of the directors in this particular case. The content of our reports in relation to this are confidential and must be submitted to the Department for Business, Innovation and Skills within six months of our appointment as Joint Administrators.

9 Statement of Affairs

9 1 Attached at Appendix E is a copy of the directors' Estimated Statement of Affairs for the Companies as at the date of the appointment of the Administrators together with a list of creditors at the time of appointment whose details have been provided by the directors. Please note that the format of the Statement of Affairs does not include any provision for the costs of the Administrations. An estimate of the return to creditors based on the information provided by the directors, and from our work to date, is included in the next section of the report.

9 2 Under the terms of cross-guarantees provided by the Companies, the Secured Creditors are shown as being owed money by each of the Companies. The Administration of 2e2 Ltd triggered an event of cross-default resulting in each of the Companies being jointly and severally liable for the secured debt.

9 3 Our commentary on the Statement of Affairs for certain entities is included at Appendix E.

10 Estimated Outcome

10 1 Creditors should be aware that it is often difficult to predict the likely dividend levels at the start of an Administration. Our comments are based on the realisations to date, and our expectations of further asset realisations into the Administration estates.

The general positions of each of the categories of creditor are shown below. Indicative outcomes for creditors of each entity are shown in Appendix B.

- **Secured Creditors** – £7.4m of cash on appointment was set-off by the Secured Creditors against amounts due. Fixed charge distributions of £11.2m and £3.8m have been made to date from MOH and 2e2 Ltd respectively.

There is expected to be a significant shortfall to secured creditors as total secured debt at the date of our appointment was c £257.2m.

- **Preferential creditors** – Under the Act the only classes of preferential creditor are employees in respect of certain claims in relation to arrears of wages, holiday and pensions contributions, as has previously been communicated to employees. In the event that there is a surplus of floating charge realisations after Administration costs have been met, a dividend will be paid to preferential creditors.

The majority of the Companies' employees were employed by 2e2 UK, but we understand that a small number of employees were employed by Holdings and one employee was employed by 2e2 Ltd. We currently anticipate that there will be sufficient floating charge realisations (after costs) to permit a dividend to preferential creditors of 2e2 UK, but that no dividend will be payable from Holdings. We are currently unable to confirm the dividend rate payable from 2e2 UK as there are a number of floating charge assets to be realised and we are yet to receive a final schedule of preferential creditor claims.

We are not aware of any preferential creditor claims against any other entity.

- **Prescribed Part** – Under Section 176A of the Act where after 15 September 2003 the Company has granted a creditor a floating charge, a proportion of the net property of the company achieved from Floating Charge asset realisations must be made available for the unsecured creditors.

The Prescribed Part applies where there are net floating charge realisations (i.e. after costs of realisation) available to unsecured creditors, and is calculated as follows:

- 50% of net property up to £10k
- Plus 20% of net property in excess of £10k
- Subject to a maximum of £600k

It is estimated that a Prescribed Part dividend is only potentially available in 2e2 UK and Diagonal. In the event that there is a Prescribed Part dividend this will be distributed equally to all agreed unsecured creditors, with the dividend dependent upon the level of claims received. Given the level of unsecured creditor claims, any dividend rate from the Prescribed Part is expected to be de-minimus.

The requirement to make the Prescribed Part distribution to unsecured creditors is disapplied if, *inter alia*, the administrator or liquidator either:

- thinks that the cost of making a distribution to unsecured creditors would be disproportionate to the benefits (s176A(3)(b)), or
- applies to the court for an order on such grounds and the court so orders (s176A(5)).

The administrators will consider the level of any potential dividend in due course and assess whether the cost of making a distribution is disproportionate to the benefits. Further information would be provided to creditors in relation to this.

- **Unsecured Creditors** – Based on the information available we estimate that there will no funds available to distribute to unsecured creditors of any of the Companies other than that distributed under the Prescribed Part, should one be payable.

11 Administrators' Remuneration and Disbursements

Pre-administration fees

- 11.1 FTI's initial proposed engagement scope was to support a refinancing with a focus on immediate short term cash flows and the Group's funding requirements. However, following our initial field work it became apparent that the Group faced a considerable and immediate liquidity gap threatening the Group's viability. Our focus therefore shifted to advising the senior secured lenders on strategic options and contingency planning for the event of an insolvency.
- 11.2 In accordance with Rule 2.33 (2B) it should be noted that FTI Consulting LLP billed total fees of £128,245.00 (plus VAT) to 2e2 Group during the period 25 January 2013 to 28 January 2013 in relation to work carried out with a view to the Companies entering Administration. As discussed at point 3.8 of this report, once it became apparent that there was no alternative to placing the Companies into administration we commenced a period of information gathering.

and planning to facilitate the Companies being placed into administration. It was important that this work commenced prior to the Companies being placed into administration, to be able to immediately implement the Administration strategy on appointment.

11.3 Our work prior to the Administrations focussed on the following work streams

- **M&A information** Gathering information for UK business sales process and international sales process
- **Assessment of required business units** Developing the trading strategy for the Administration and potential unit closures/trade-ons
- **Appointment strategy and documentation** Preparation of appointment documentation and day one communications
- **Strategy and planning** Plans to establish control over business locations and other planning including taxation matters
- **Employees** Assessment of staff retentions/redundancies, establishment of employee numbers/locations and communications plan

11.4 All pre-appointment costs referred to above were paid prior to our appointment and a request to draw these fees as an expense of the Administration will therefore not be made. We are not aware of any other costs or expenses incurred in relation to the Companies by another party qualified to act as an insolvency practitioner in the period prior to our appointment as Administrators, in respect of work with a view to placing the Companies into Administration. We understand that the directors sought the advice of PriceWaterhouseCoopers prior to placing the Companies into administration, but no request to pay any fees in respect of this advice has been received, and we understand their fees were settled pre-appointment. c. £45k was paid to DLA Piper post-appointment in respect of legal advice that the directors received prior to the commencement of the administration in relation to placing the Companies into Administration.

Post-appointment fees

11.5 It is proposed that the remuneration of the Administrators will be fixed by reference to the time spent by the Administrators' and their staff in carrying out the Administrations, in accordance with Rule 2.106 of the Rules. The timing of the exit of the Administrations will depend on the progress of realisations of assets and the completion of the work streams discussed in the body of this report.

11.6 We have attached at Appendix F a Time Analysis in accordance with the provisions of SIP9, which provides details of the activity costs incurred by staff grade to the above date.

11.7 The Administrators have currently incurred time costs of £2,476,722.02 (net of VAT) properly dealing with the Administrations of the Companies. The time costs incurred by entity are shown in the table in Appendix B with the full fee analysis in accordance with SIP9 shown in Appendix F. No fees have yet been drawn.

11.8 In addition the Administrators have currently incurred Category 1 expenses of £25,897.85. The expenses costs incurred by entity are shown in the table in Appendix B.

11.9 Attached as Appendix G is additional information in relation to our policy on staffing, the use of sub contractors, disbursements and details of our current charge out rates by staff grade.

Fee Approval

11.10 Other than any potential distributions under the Prescribed Part, we do not currently anticipate that any funds will be available to the unsecured creditors. Therefore, fixing the basis of the Administrators' remuneration will be approved in accordance with Rule 2.106(5A) of the Rules. These rules are outlined as follows:

- 11 11 Where the Administrators have made a statement under Paragraph 52(1)(b) of Schedule B1 of the Act the basis of the Administrators' remuneration may be fixed by approval of
- Each secured creditor, or
 - If the Administrators intend to make a distribution to preferential creditors, with the approval of each secured creditor and 50% of the preferential creditors who respond to an invitation to consider approval
- 11 12 In line with Paragraph 52(1)(b) of Schedule B1 of the Act outlined above there is no requirement for unsecured creditors to pass a resolution in respect of Administrators' remuneration

- 11 14 Creditors attention is drawn to Appendix H of this report which shows extracts from the Rules detailing creditors ability to request further information in relation to the Administrators' fees or to challenge the Administrators' remuneration

12 Administrators' Proposals

- 12 1 As outlined above the objectives of the Administrations are achieving a better result for the Companies' creditors as a whole than would be likely if the Companies were wound up
- 12 2 The contents of this document represent the Administrators' proposals. In order to provide clarity to creditors on the further specific areas for which the Administrators are seeking approval we have set out our specific proposals in three subsections below

Proposed Strategy, Actions and Activities

- a The Administrators will continue to manage the affairs of the Companies in order to achieve the purpose of the Administration
- b To do all such other things and generally exercise all of their powers as contained in Schedule B1 of the Act, as the Administrators consider desirable or expedient to achieve the statutory purpose of the Administration
- c To investigate and as appropriate pursue any claims the Companies may have
- d The Administrators be authorised to agree the claims of the secured, preferential and unsecured creditors against each of the Companies unless they conclude, in their reasonable opinion, that a company will have no assets available for distribution
- e The Administrators be authorised to distribute funds to the secured and preferential creditors as and when claims are agreed and funds permit. In relation to potential distributions to unsecured creditors, that the Administrators, at their discretion, may make an application to court for permission to make distributions to unsecured creditors under Paragraph 65(3) of Schedule B1 of the Act
- f That, in the event the creditors of each company so determine, a creditors committee be appointed in respect of each or any company comprising of not more than five and not less than three creditors of that company

Proposed Exit Routes

The most likely deemed exit route for each company is shown in the table at Appendix B. The possible exit routes are discussed in more detail below.

- g In relation to all Companies, once all assets have been realised, and if there are no funds available to enable a distribution to the unsecured creditors and a liquidation process is not required, the Administrators shall file a notice pursuant to paragraph 84 of Schedule B1 to the Act together with their final progress report at Court and with the Registrar of Companies for the dissolution of the Companies.
- h Should dissolution not be deemed to be the most appropriate exit route, the Joint Administrators may exit the Companies' Administrations into Creditors' Voluntary Liquidation pursuant to paragraph 83 of Schedule B1 to the Act in order to make the distribution to unsecured creditors. It is proposed that the Administrators would be appointed as liquidators, with any liquidator being able to undertake acts required or authorised under any enactment individually. The creditors are entitled to nominate a different person as the proposed liquidator, provided that the nomination is made after the receipt of these proposals and before the proposals are approved.
- i In the event that there are no distributions to unsecured creditors, but the Administrators still believe liquidation to be the most appropriate route (for example if investigation work is required within a liquidation process or it is necessary to disclaim a lease), the Administrators will exit the Administrations by compulsory liquidations. The Administrators give notice that on such a petition the Joint Administrators will seek their appointment as liquidators pursuant to section 140 of the Act.
- j The Administrators will be discharged from liability in accordance with Paragraph 98(1) of Schedule B1 of the Act immediately upon their appointment as Administrators ceasing to have effect.

Administrators' Remuneration

- k That in respect of each company the creditors committee, if one is appointed, be asked to agree that the basis of the Administrators' remuneration be fixed by reference to the time properly given by the Administrators' and their staff in attending to matters arising in the Administrations, calculated at the prevailing standard hourly charge out rates used by FTI at the time when the work is performed, plus VAT, and be asked to agree the Administrators' expenses.
- l That if a creditors' committee is not appointed, the Secured Creditors (and preferential creditors where applicable) of each company shall be asked to fix the basis of the Administrators' remuneration in accordance with Rule 2.106(5A)(a) of the Rules, to be fixed by reference to the time properly given by the Administrators' and their staff in attending to matters arising in the Administrations, calculated at the prevailing standard hourly charge out rates used by FTI at the time when the work is performed, plus VAT.

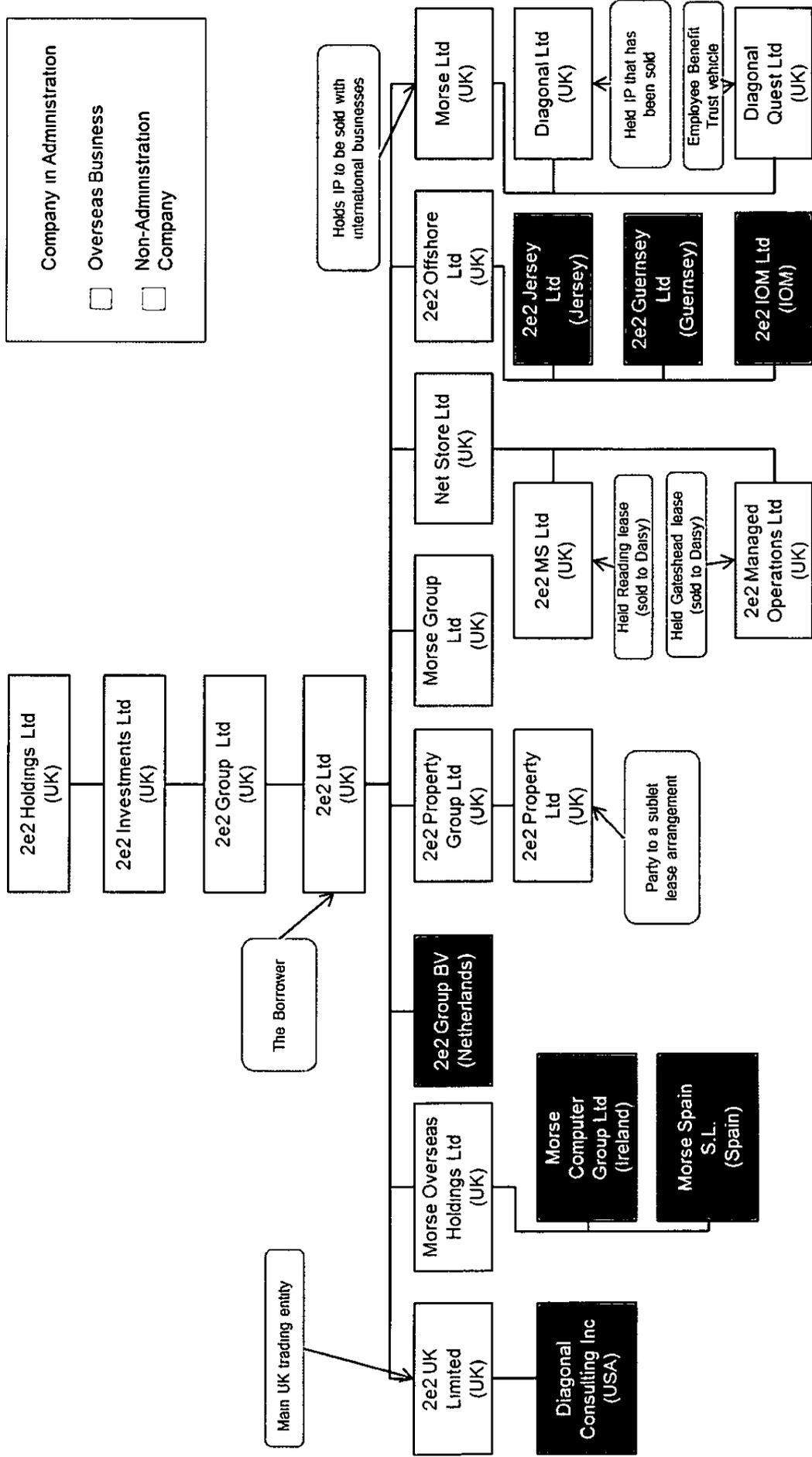

1.1 Staff Allocation and the use of Sub-contractors

Our general approach to resourcing our assignments is to allocate staff with the skills and experience to meet the specific requirements of the case

The constitution of the case team will usually consist of a Senior Managing Director, Managing Director, Director, Senior Consultant and Consultant. The exact constitution of the case team will depend on the anticipated size and complexity of the assignment and on larger, more complex cases, several Senior Consultants/Consultants may be allocated to meet the demands of the case

With regard to support staff, we would advise that time spent by cashiers in relation to specific tasks on an assignment is charged. 1.1 Rule 2.48A - Creditors' request for further information

- (1) If –
- (a) Within 21 days of receipt of a progress report under Rule 2.47 –
 - (i) a secured creditor, or
 - (ii) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question) or
 - (b) with the permission of the court upon an application made within that period of 21 days, any unsecured creditor,
- makes a request in writing to the administrator for further information about remuneration or expenses (other than pre-administration costs) set out in a statement required by Rule 2.47(1)(db) or (dc), the administrator must, within 14 days of receipt of the request, comply with paragraph (2)
- (2) The administrator complies with this paragraph by either—
- (a) providing all of the information asked for, or
 - (b) so far as the administrator considers that—
 - (i) the time or cost of preparation of the information would be excessive, or
 - (ii) disclosure of the information would be prejudicial to the conduct of the administration or might reasonably be expected to lead to violence against any person, or
 - (iii) the administrator is subject to an obligation of confidentiality in respect of the information,
- giving reasons for not providing all of the information
- (3) Any creditor, who need not be the same as the creditor who requested further information under paragraph (1), may apply to the court within 21 days of—
- (c) the giving by the administrator of reasons for not providing all of the information asked for, or
 - (d) the expiry of the 14 days provided for in paragraph (1),
- and the court may make such order as it thinks just
- (4) Without prejudice to the generality of paragraph (3), the order of the court under that paragraph may extend the period of 8 weeks provided for in Rule 2.109(1B) by such further period as the court thinks just

1.2 Rule 2.109 - Creditors' claim that remuneration is [or other expenses are] excessive

- (1) Any secured creditor, or any unsecured creditor with either the concurrence of at least 10% in value of the unsecured creditors (including that creditor) or the permission of the court, may apply to the court for one or more of the orders in paragraph (4)
- (1A) An application may be made on the grounds that—
- (a) the remuneration charged by the administrator,
 - (b) the basis fixed for the administrator's remuneration under Rule 2.106,
 - (c) expenses incurred by the administrator,
- is or are in all the circumstances, excessive, or in the case of an application under sub-paragraph (b), inappropriate
- (1B) The application must, subject to any order of the court under Rule 2.48A(4), be made no later than 8 weeks after receipt by the applicant of the progress report which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report")

- (2) The court may, if it thinks that no sufficient cause is shown for a reduction, dismiss it without a hearing but it shall not do so without giving the applicant at least 5 business days' notice, upon receipt of which the applicant may require the court to list the application for a without notice hearing. If the application is not dismissed, the court shall fix a venue for it to be heard, and give notice to the applicant accordingly.
- (3) The applicant shall, at least 14 days before the hearing, send to the administrator a notice stating the venue and accompanied by a copy of the application, and of any evidence which the applicant intends to adduce in support of it.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders—
- (a) an order reducing the amount of remuneration which the administrator was entitled to charge,
 - (b) an order fixing the basis of remuneration at a reduced rate or amount,
 - (c) an order changing the basis of remuneration,
 - (d) an order that some or all of the remuneration or expenses in question be treated as not being expenses of the administration,
 - (e) an order that the administrator or the administrator's personal representative pay to the company the amount of the excess of remuneration or expenses or such part of the excess as the court may specify,
- and may make any other order that it thinks just, but an order under sub-paragraph (b) or (c) may be made only in respect of periods after the period covered by the relevant report.
- (5) Unless the court orders otherwise, the costs of the application shall be paid by the applicant, and are not payable as an expense of the administration.
