

MEMORANDUM OF ASSOCIATION

of

THE HEALTHCARE FOUNDATION*

- 1. The name of the Company is The Healthcare Foundation.
- 2. The registered office of the Company will be situate in England.
- 3. (a) The objects for which the Company is registered are the conduct and promotion of research and the dissemination of the useful products thereof into the causes, origins, transmission and treatment of the disease or condition known as Acquired Immune Deficiency Syndrome and any apparantly related, similar or consequent disease or condition, the promotion by charitable means of the welfare of sufferers from such diseases or conditions, the alleviation of physical, mental or financial deprivation caused by such diseases or conditions, the advancement of education in matters relevant thereto and the support of charities in furthering the said objects or any of them
 - (b) In furtherance of these objects but not further or otherwise the Company shall have the following powers:-
 - (i) To carry on research and development work and experiments and testing of any kind with material, substances and chemicals of any nature
 - (ii) To select and train people of skill and sympathy to counsel or treat individuals or groups and to promote, organise, provide and manage educational programmes and displays for the information of the public and the training of individuals able to assist in promoting the objects of the Company and to provide counsel, support, advice, assistance, treatment and other services to individuals suffering from Acquired Immune Deficiency Syndrome or any apparently similar, related or consequent disease or condition
 - (iii) To enter into agreements and engagements with scientists, researchers, teachers, lecturers, advisors, members of the medical and nursing professions and other exponents of medicine and education and to remunerate such persons and advisors by salaries or fees

- (iv) To co-operate with manufacturers, dealers, traders, the press and other sources of publicity for the purpose of promoting the objects of the Company
- (v) To procure to be written and print, publish, issue, circulate or otherwise disseminate gratuitously or otherwise, reports and periodicals, books, pamphlets, leaflets and other literature
- (vi) To raise funds and to invite and receive contributions from any person or persons whatsoever by way of subscription, donation and otherwise provided that the Company shall not undertake any permanent trading activity in raising funds for its objects
- (vii) To take and accept any gifts of property of any description whether subject to any special trusts or not, for the purposes of the Company
- (viii) To undertake and execuce any charitable trusts
 - (ix) To co-operate with other charitable organisations having similar objects and to establish, promote or assist such charitable organisations
 - (x) To purchase, acquire or undertake all or any of the property, liabilities and engagements of such charitable organisations and institutions with which the Company may co-operate or federate
 - (xi) To purchase, lease, hire or otherwise acquire and to sell, let, mortgage, dispose of, turn to account and subject to such consents as may be required by law from time to time otherwise deal with real and personal property and any rights or privileges to promote the objects of the Company and to maintain, construct, alter, pull down and convert buildings for the purposes of the Company
 - (xii) Subject to such consents as may be required by law from time to time and subject as hereinafter provided to borrow or raise money and to execute and issue security as the Company shall think fit including mortgages, charges or securities over the whole or any part of its assets, present or future
 - (xiii) To lend money and extend credit and to take security for such loans or credit and to guarantee, become or give security for the performance of contracts by any person firm or company as may be necessary for the furtherance of the objects of the Company
 - (xiv) To draw, accept, endorse, issue or execute promissory notes, bills of exchange, bills of lading, warrants, and other negotiable, transferable, or mercantile instruments, for the purpose of or in connection with the objects of the Company

- (XV) To invest and deal with the moneys of the Company not immediately required in such manner as the Company may from time to time determine subject nevertheless to such conditions (if any) and such consents (if any) as may for the time being be imposed or required by law and subject also as hereinafter provided
- (xvi) As employers of staff to make all reasonable and necessary provision for the payment of superannuation and pensions to or on behalf of employees and their dependants
- (xvii) To pay out of the funds of the Company the costs of forming and registering the Company
- (xviii) To do all such other lawful things as shall further the attainment of the objects of the Company

(c) PROVIDED THAT:-

- (i) In case the Company shall take or hold any property which may be subject to any trust, the Company shall only deal with or invest the same in such a manner as allowed by law, having regard to such trusts
- (ii) The Company's objects shall not extend to the regulation of relations between employees or organisations of employees and employers or organisations of employers
- (iii) In case the Company shall take or hold any property subject to the jurisdiction of the Charity Commissioners for England and Wales, the Company shall not sell, mortgage, charge or lease the same without such authority, approval or consent as may be required by law, and as regards any such property the Trustees and Members of the Company shall be chargeable for any such property that may come into their hands and shall be answerable and accountable for their own acts, receipts, neglects and defaults, and for the due administration of such property in the same manner and to the same extent as they would have been if no incorporation had been effected and the incorporation of the Company shall not diminish or impair any control or authority exercisable by the Chancery Division or the Charity Commissioners over such Trustees and Members of the Company, but they shall as regards any such property be subject jointly and separately to such control or authority as if the Company were not incorporated
- 4. The income and property of the Company shall be applied solely towards the promotion of its objects as set forth in this Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit, to members of the Company and no director of the Company shall be appointed to any office of the Company paid by salary or fees, or receive any remuneration or other benefit in money or money's worth from the Company Provided that nothing herein shall prevent any payment in good faith by the Company:-

- (a) of reasonable and proper remuneration to any member, officer or servant of the Company (not being a Trustee of the Company) for any services rendered to the Company and to any Trustee of the Company being a solicitor or other person engaged in any profession who shall be entitled to charge and be paid all usual professional or other charges for work done in connection with the execution of the objects hereof
- (b) of interest on money lent by any member of the Company or its Trustees at a reasonable and proper rate per annum
- (c) to any of the Company's Trustees of reasonable out-of-pocket expenses
- (d) to a company of which any Trustee of the Company may be a member holding not more than one hundredth part of the capital of such company
- 5. The liability of the Members is limited
- 6. Every Member of the Company undertakes to contribute to the assets of the Company in the event of its being wound up during the Member's period of Membership or within one year afterwards for payment of the debts and liabilities of the Company contracted before the Member ceases to be a Member and of the costs, charges and expenses of winding up the same and for the adjustment of the rights of the contributories amongst themselves such amount as may be required not exceeding in the case of any Member the sum of £1
- 7. If upon the winding up or dissolution of the Company there remains after satisfaction of its debts and liabilities any property whatsoever the same shall not be paid to or distributed among the Members but shall be given or transferred to some other charity having objects similar to those of the Company and which shall be established for charitable purposes only and which shall prohibit the distribution of its income and property among its Members to an extent at least as great as that imposed on the Company by Clause 4 hereof such charity to be determined by the Members of the Company at or before the time of dissolution and if and so far as effect cannot be given to the aforesaid provision then to some charitable object
- 8. True accounts shall be kept of the sums of money received and expended by the Company and the matters in respect of which such receipts and expenditure take place and of the property, credits and liabilities of the Company and subject to any reasonable restrictions that may be imposed in accordance with regulations of the Company for the time being in force shall be open to the inspection of the Members Once at least in every year the accounts of the Company shall be audited and the correctness of the balance sheet ascertained by a properly qualified auditor

ARTICLES OF ASSOCIATION

of

THE HEALTHCARE FOUNDATION*

1. In these Articles:-

"the Act" means the Companies Act 1985 including any statutory modification or re-enactment thereof for the time being in force "clear days" in relation to the period of a notice means that period excluding the day when the notice is given or deemed to be given and the day for which it is given or on which it is to take effect

"the Seal" means the common seal of the Company

"Secretary" means any person appointed to perform the duties of the Secretary of the Company

"the United Kingdom" means Great Britain and Northern Ireland Expressions referring to writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and other modes of representing or reproducing words in a visible form

Unless the context otherwise requires words or expressions contained in these Articles shall bear the same meaning as in the Act

MEMBERS

- 2. The Company is established for the purposes expressed in the Memorandum of Association
- 3. The number of Members with which the Company proposes to be registered is unlimited
- 4. (a) The subscribers to the Memorandum of Association and such other persons as the Trustees shall admit to membership shall be Members of the Company
 - (b) The rights and privileges of a Member shall not be transferable
 - (c) No person shall be admitted to membership unless that person is prepared to use best endeavours to assist in the advancement of the main objects of the Company
- 5. A Member shall cease to be a Member of the Company:-
 - (if a corporation) upon its having a winding up resolution passed or winding up petition presented or a receiver being appointed of any of its assets
- * As amended by Special Resolutions dated 20.10.87 and 29.1.88

- (b) upon giving notice in writing to the Company resigning from membership
- (c) upon a two-thirds majority of the Trustees of the Company giving the Member notice requiring the Member to resign from membership
- (d) (if an individual) upon dying, becoming of unsound mind, or bankrupt, or compounding with creditors

REGISTERS

- 6. The Trustees shall cause the following registers to be kept at the Registered Office of the Company:-
 - (a) Register of Members
 - gister of the interests of the Trustees in debentures of the pany or its associated Companies
- 7. The Trustees shall cause such Registers as are kept under the provisions of Article 6 hereof to be completed and made available for inspection in accordance with the provisions of the Act

GENERAL MEETINGS

- 8. The Company shall in each year hold a General Meeting as its Annual General Meeting in addition to any other meetings in that year, and shall specify the meeting as such in the notice calling it; and not more than fifteen months shall elapse between the date of one Annual General Meeting of the company and that of the next Provided that so long as the Company holds its first Annual General Meeting within eighteen months of its incorporation, it need not hold it in the year of its incorporation or in the following year The Annual General Meeting shall be held at such time and place as the Trustees shall appoint
- 9. All General Meetings other than Annual General Meetings shall be called Extraordinary General Meetings
- 10. The Trustees may, whenever they think fit, convene an Extraordinary General Meeting, and Extraordinary General Meetings shall also be convened on such requisition, or, in default, may be convened by such requisitionists, as provided by Section 368 of the Act If at any time there are not within the United Kingdom sufficient Trustees capable of forming a quorum, any Trustee or any two Members of the Company may convene an Extraordinary General Meeting in the same manner as nearly as possible as that in which meetings may be convened by the Trustees

NOTICE OF GENERAL MEETINGS

11. An Annual General Meeting and a meeting called for the passing of a Special Resolution or a resolution appointing a person as a Trustee shall be called by twenty one clear days' notice in writing at the least, and a meeting of the Company other than an Annual General Meeting or a meeting for the passing of a Special Resolution shall be

called by fourteen clear days' notice in writing at the least The notice shall specify the place, the day and the hour of meeting and, in case of special business, the general nature of that business and shall be given, in manner hereinafter mentioned or in such other manner, if any, as may be prescribed by the Company in General Meeting, to such persons as are, under the Articles of the Company, entitled to receive such notice from the Company Provided always that a meeting of the Company shall, notwithstanding that it is called by shorter notice than that specified in this Article be deemed to have been duly called if it is so agreed:—

- (a) in the case of a meeting called as the Annual General Meeting, by all the Members entitled to attend and vote thereat; and
- (b) in the case of any other meeting, by a majority in number of the Members having a right to attend and vote at the meeting, being a majority together holding not less than ninety five per cent of the total voting rights at that meeting of all the Members
- 12. The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting

PROCEEDINGS AT GENERAL MEETINGS

- 13. All business shall be deemed special that is transacted at an Extraordinary General Meeting, and also all that is transacted at an Annual General Meeting, with the exception of the consideration of the accounts, balance sheets, and the reports of the Trustees and Auditors, the election of Trustees in the place of those retiring and the appointment of, and the fixing of the remuneration of the Auditors
- 14. No business shall be transacted at any General Meeting unless a quorum of Members is present at the time when the meeting proceeds to business; save as herein otherwise provided, three Members or 1/10th of the membership whichever is the greater present in person or by proxy shall be a quorum
- 15. If within half an hour from the time appointed for the meeting a quorum is not present, the meeting, if convened upon the requisition of Members, shall be dissolved; in any other case it shall stand adjourned to the same day in the next week, at the same time and place, or to such other day and at such other time and place as the Trustees may determine, and if at the adjourned meeting a quorum is not present within half an hour from the time appointed for the meeting the Members present shall be a quorum
- 16. The Chairman, if any, of the Board of Trustees shall preside as Chairman at every General Meeting of the Company, or if there is no such Chairman, or if the Chairman shall not be present within fifteen minutes after the time appointed for the holding of the meeting or is unwilling to act the Trustees present shall elect one of their number to be Chairman of the meeting
- 17. If at any meeting no Trustee is willing to act as Chairman or if no Trustee is present within fifteen minutes after the time appointed for

holding the meeting, the Members present shall choose one of their number to be Chairman of the meeting

- 18. The Chairman may, with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place When a meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting Save as aforesaid it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting
 - 19. At any General Meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands) demanded (a) by the Chairman or (b) by at least two Members present in person or by proxy or (c) by any Member or Members present in person or by proxy and representing not less than one-tenth of the total voting rights of all representing not less than one-tenth of the total voting rights of all representing the right to vote at the meeting. Unless a poll be the Members having the right to vote at the meeting. Unless a poll be so demanded a declaration by the Chairman that a resolution has on a show of hands been carried or carried unanimously, or by a particular show of hands been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing majority, or lost, and an entry to that effect in the book containing the minutes of proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes of the fact without proof of against such resolution. The demand for a poll may be withdrawn
 - 20. Except as provided in Article 22 if a poll is duly demanded it shall be taken in such manner as the Chairman directs, and the result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded
 - 21. In the case of an equality of votes, whether on a show of hands or on a poll, the Chairman of the meeting at which the show of hands takes place or at which the poll is demanded, shall be entitled to a second or casting vote
 - 22. A poll demanded on the election of a Chairman, or on a question of adjournment, shall be taken forthwith A poll demanded on any other question shall be taken at such time as the Chairman of the meeting question, and any business other than that upon which a poll has been demanded may be proceeded with pending the taking of the poll
 - 23. Subject to the provisions of the Act a resolution in writing signed by all the Members for the time being entitled to receive notice of and to attend and vote at General Meetings (or being corporations by their duly authorised representatives) shall be as valid and effective as if the same had been passed at a General Meeting of the Company duly convened and held
 - 24. If at any General Meeting any votes shall be counted which ought not to have been counted, or might have been rejected, the error shall not vitiate the results of the voting unless it be pointed out at the same meeting, and not in that case unless it shall, in the opinion of the Chairman of the Meeting, be of sufficient magnitude to vitiate the result of the voting

VOTES OF MEMPERS

- 25. Every Member shall have one vote
- 26. On a poll votes may be given either personally or by proxy
- 27. The instrument appointing a proxy shall be in writing under the hand of the appointor or of the appointor's attorney duly authorised in writing, or, if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised A proxy need not be a Member of the Company
- 28. The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority shall be deposited at the registered office of the Company or at such other place within the United Kingdom as is specified for that purpose in the notice convening the meeting, not less than forty eight hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, or, in the case of a poll, not less than twenty four hours before the time appointed for the taking of the poll, and in default the instrument of proxy shall not be treated as valid
- 29. An instrument appointing a proxy shall be in the following form or a form as near thereto as circumstances admit:-

30. The instrument appointing a proxy shall be deemed to confer authority to demand or join in demanding a poll

CORPORATIONS ACTING BY REPRESENTATIVES AT MEETINGS

31. Any corporation which is a Member of the Company may by resolution of its Trustees or other governing body authorise such person as it thinks fit to act as its representative at any meeting of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation represented as that corporation could exercise if it were an individual Member of the Company

TRUSTEES

- 32. Until otherwise determined by a General Meeting the number of Trustees shall be not less than three nor more than thirty The subscribers to the Memorandum of Association shall be the first Trustees of the Company
- 33. The Trustees shall have power at any time, and from time to time, to spoint any person to be a Trustee, either to fill a casual vacancy or as an addition to the existing Trustees, but so that the total number of Trustees shall not at any time exceed the number fixed in accordance with these Articles Any Trustee so appointed shall hold office only until the next following Annual General Meeting, and shall then be eligible for re-election, but shall not be taken into account in determining the Trustees who are to retire by rotation at such meeting
- 34. No person who is not a Member of the Company shall be entitled to hold office as a Trustee
- 35. No Trustee shall vacate office or be ineligible for re-appointment as a Trustee nor shall any person be ineligible for appointment as a Trustee by reason only of having attained any particular age

BORROWING POWERS

36. The Trustees may exercise all the powers of the Company to borrow money, and to mortgage or charge its undertaking and property, or any part thereof, and to issue debentures, debenture stock and other securities, whether outright or as security for any debt, liability or obligation of the Company or of any third party

POWERS AND DUTIES OF TRUSTESS

- 37. The business of the Company shall be managed by the Trustees who shall be its committee of Management and Governing Body and who may pay all expenses incurred in promoting and registering the Company, and may exercise all such powers of the Company as are not, by the Act or by these Articles, required to be exercised by the Company in General Meeting, subject nevertheless to the provisions of the Act or these Articles and to such regulations, being not inconsistent with the aforesaid provisions, as may be prescribed by the Company in General Meeting; but no regulation made by the Company in General Meeting shall invalidate any prior act of the Trustees which would have been valid if that regulation had not been made In particular the Trustees shall have power to make rules and bye-laws for regulating the use by Members and others of any property of the Company
- 38. All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments, and all receipts for moneys paid to the Company, shall be signed, drawn, accepted, endorsed, or otherwise executed, as the case may be, in such manner as the Trustees shall from time to time by resolution determine
- 39. The Trustees shall cause minutes to be made of all appointments of officers made by them, of the names of the Trustees present at each meeting of the Trustees and of any committee of the Trustees, and of all resolutions and proceedings at all meetings of the Company, and of

the Trustees, and of committees of Trustees and any such minutes if signed by the Chairman of such meeting or by the Chairman of the next succeeding meeting shall be sufficient evidence without any further proof of the facts therein stated

40. The Trustees may act notwithstanding any vacancy in the Board but if the number of Trustees is less than the minimum prescribed herein they may only act as Trustees to admit persons to membership of the Company fill vacancies in the Board of Trustees or summon a General Meeting

DISQUALIFICATION OF TRUSTEES

- 41. (a) The office of Trustee shall be vacated if the Trustee:-
 - (i) becomes subject to a receiving order or makes an arrangement or composition with creditors generally
 - (ii) becomes prohibited by law from being a Trustee or ceases to be a Trustee by reason of any provision of the Act or
 - (iii) becomes of unsound mind or
 - (iv) resigns from office by notice in writing to the Company or
 - (v) is removed from office by a resolution duly passed pursuant to Section 303 of the Act or
 - (vi) ceases to be a Member of the Company or
 - (vii) is directly or indirectly interested in any contract with the Company and fails to declare the nature of such interest in the manner required by Section 317 of the Act
 - (b) A Trustee shall not vote in respect of any contract in which the Trustee is interested or any matter arising thereout and if the Trustee does so vote such vote shall not be counted
 - 42. The Company may by ordinary resolution of which special notice has been given in accordance with Section 379 of the Act, remove any Trustee before the expiration of the Trustee's period of office notwithstanding anything in these Articles or in any agreement between the Company and such Trustee
 - 43. The Company may by ordinary resolution appoint another person in place of a Trustee removed from office under the immediately preceding article Without prejudice to the powers of the Trustees under Article 33 the Company in General Meeting may appoint any person to be a Trustee either to fill a casual vacancy or as an additional Trustee The person appointed to fill such a vacancy shall be subject to retirement at the same time as if that person had become a Trustee on the day on which the Trustee in whose place that person is appointed was last elected a Trustee

PROCEEDINGS OF TRUSTEES

44. (a) The Trustees may meet together for the despatch of business,

adjourn, and otherwise regulate their meetings, as they think fit Questions arising at any meeting shall be decided by a majority of votes. In the case of an equality of votes the Chairman shall have a second or casting vote. A Trustee may, and the Secretary on the requisition of a Trustee shall, at any time summon a meeting of the Trustees. It shall not be necessary to give notice of a meeting of Trustees to any Trustee for the time being absent from the United Kingdom. The quorum necessary for the transaction of the business of the Trustees shall be three directors or one third of the directors for the time being whichever is greater.

- (b) The Trustees may elect a Chairman of their meetings and determine the period for which the Chairman is to hold office; but, if no such Chairman is elected, or if at any meeting the Chairman is not present within five minutes after the time appointed for holding the same, the Trustees present may choose one of their number to be Chairman of the meeting
- (c) A meeting of the Trustees at which a quorum is present, shall be competent to exercise all the authorities, powers and discretions by or under the regulations of the Company for the time being vested in the Trustees generally
- 45. The Trustees may delegate any of their powers to committees consisting of such Trustees as they think fit; any committee so formed shall in the exercise of the powers so delegated conform to any regulations that may be imposed on it by the Trustees All acts and proceedings of such committees shall be reported as soon as is reasonably practicable to the full body of Trustees
- 46. A Committee may elect a Chairman of its meetings; if no such Chairman is elected, or if at any meeting the Chairman is not present within five minutes after the time appointed for holding the same, the Members present may choose one of their number to be Chairman of the meeting
- 47. A Committee may meet and adjourn as it thinks proper Questions arising at any meeting shall be determined by a majority of votes of the Members present, and in the case of an equality of votes the Chairman shall have a second or casting vote
- 48. All acts done by any meeting of the Trustees or of a committee of Trustees. or by any person acting as a Trustee shall notwithstanding that it be afterwards discovered that there was some defect in the appointment of any such Trustee or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Trustee
- 49. A resolution in writing, signed by all the Trustees for the time being entitled to receive notice of a meeting of the Trustees, shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly convened and held

THE SECRETARY

50. The Secretary not being a Trustee shall be appointed by the Trustees for such term, at such remuneration and upon such conditions as they may think fit; and any Secretary so appointed may be removed by them

THE SEAL

51. The Trustees shall provide for the safe custody of the Seal, which shall only be used by the authority of the Trustees or of a committee of the Trustees authorised by the Trustees in that behalf, and every instrument to which the Seal shall be affixed shall be signed by a instrument to which the Seal shall be affixed shall be signed by a Trustee and shall be countersigned by the Secretary or by a second Trustee or by some other person appointed by the Trustees for the purpose

ACCOUNTS AND TRUSTEES REPORT

- 52. The Trustees shall cause proper books of account to be kept in accordance with the provisions of Section 221 of the Act with respect to:-
 - (a) all sums of money received and expended by the Company and the matters in respect of which the receipt and expenditure takes place
 - (b) the assets and liabilities of the Company and
 - (c) all those matters required by the Act to be shown in the Accounts of the Company

Proper books shall not be deemed to be kept if there are not kept such books of account as are necessary to give a true and fair view of the state of the Company's affairs and to explain its transactions

- 53. (a) The books of account shall be kept at the registered office of the Company, or, subject to Section 222 of the Act at such other place or places as the Trustees think fit, and shall always be open to the inspection of the Trustees
 - (b) The Trustees shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations the accounts and books of the Company or any of them shall be open to the inspection of Members not being Trustees, and no Member (not being a Trustee) shall have any right of inspecting any account or books or document of the Company except as any account or books or document of the Trustees or by the conferred by Statute or authorised by the Trustees or by the Company in General Meeting subject nevertheless to the provision of Clause 8 of the Memorandum of Association of the Company
 - 54. The Trustees shall from time to time cause to be prepared and laid before the Company in General Meeting such profit and loss accounts, balance sheets and Trustees' reports as are provided for in the Act.

55. A copy of every balance sheet (including every document required by law to be annexed thereto) which is to be laid before the Company in General Meeting, together with a copy of the Auditor's report, shall not less than twenty one days before the date of the meeting be sent to every Member of, and every holder of debentures of, the Company, provided that this Article shall not require a copy of those documents to be sent to any person of whose address the Company is not aware

AUDIT

56. Auditors shall be appointed and their duties regulated in accordance with the Act

NOTICES

- 57. A notice may be given by the Company to any Member either personally or by sending it by post to the Member or to the Member's registered address, or (if the Member has no registered address within the United Kingdom) to the address, if any, within the United Kingdom supplied to the Company for the giving of notice Where a notice is sent by post, service of the notice shall be deemed to be effected by properly addressing, prepaying and posting a letter containing the notice, and to have been effected at the expiration of twenty four hours after the letter containing the same is posted
- 58. Notice of every General Meeting shall be given in any manner hereinbefore authorised to:-
 - (a) every Member except those Members who (having no registered address within the United Kingdom) have not supplied to the Company an address within the United Kingdom for the giving of notice to them
 - (b) the auditor for the time being of the Company

No other person shall be entitled to receive notices of General Meetings

DISSOLUTION

59. Clause 7 of the Memorandum of Association of the Company shall have effect as if the provisions thereof were repeated herein
