DIRECTORS' REPORT

The directors present their Annual Report and the audited Financial Statements of Paragon Loan Finance (No 2) Limited ('the Company'), registration no 2173065, for the year ended 30 September 2012

BUSINESS REVIEW AND PRINCIPAL ACTIVITIES

The Company is a wholly owned subsidiary of The Paragon Group of Companies PLC ('the Group') and was set up to provide finance for its consumer finance loan assets, by issuing asset backed floating rate loan notes and using the proceeds to purchase consumer loans from other group companies

The Company's principal activities are the provision of consumer finance loans. The majority of loans were sold to another group company and used the proceeds to repay the outstanding notes. The Company retained the remaining loans and continued to actively collect on these loans. The Company is currently engaged in loan relationships with other group companies. The Company provides a subordinated loan to Paragon Mortgages (No 9) PLC.

As shown in the Company's profit and loss account on page 5, the Company's net interest expense has increased from £196,000 to £210,000. This was principally due to an increase in amounts due to group companies resulting in an increase in the internal funding costs. The loss after tax has increased from £144,000 to £158,000. This was mainly due to the increase in net interest expense.

The balance sheet on page 6 of the Financial Statements shows that the Company's financial position at the year end Net liabilities have increased due to the retained loss for the year. Details of amounts owed from and to other group companies are shown in notes 7 and 10

No interim dividend was paid during the year (2011 £nil) No final dividend is proposed (2011 £nil)

The Group manages its operations on a centralised basis. For this reason, the Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business. The performance of the Group's mortgage lending operation, which includes the Company, is discussed in the Group's Annual Report, which does not form part of this Report.

PRINCIPAL RISKS AND UNCERTAINTIES

An analysis of the Company's exposure to risk, including financial risk, and the steps taken to mitigate these risks are set out in note 2

After considering the above, the directors have a reasonable expectation that the Company will have adequate resources to continue in operational existence for the foreseeable future. This is further supported by the Group holding sufficient cash resources to support the Company's obligations as they fall due. For this reason, they continue to adopt the going concern basis in preparing the Financial Statements.

The Group recognises the importance of its environmental responsibilities, monitors its impact on the environment, and designs and implements policies to reduce any damage that might be caused by the Group's activities. The Company operates in accordance with group policies, which are described in the Group's Annual Report, which does not form part of this Report.
