

"Car Finance Scottish Trust Property" means certain Scottish Car Finance Contracts, together with all monies, rights, title, benefits and proceeds relating thereto (other than any motor vehicles relative thereto), as more fully specified and defined in the Car Finance Supplemental Scottish Declaration of Trust.

"Car Finance Supplemental Scottish Declaration of Trust" means the supplemental declaration of trust dated 29 May 2002 between PCF and the Issuer.

"CMS7" means Collateralised Mortgage Securities (No. 7) plc (number 2173117).

"Deed of Charge" means the deed of charge dated 23rd November 2000 between *inter alios* the Issuer and the Trustee.


"PCF" means Paragon Car Finance Limited (number 3203928).

"Scottish Car Finance Contract" means a hire-purchase (including contract purchase) or lease or conditional sale agreement entered into by PCF with one or more persons in respect of a new or used motor vehicle governed by or otherwise subject to Scots law.

"Subordinated Lender" means a person (other than CMS7) from whom the Issuer may borrow pursuant to the Subordinated Loan Agreement which has undertaken in a manner and form reasonably satisfactory to the Trustee to be bound by the Deed of Charge as if it had originally been a party thereto.

"Subordinated Lender Secured Amounts" means any monies and liabilities which from time to time may be owing or payable from or by the Issuer to a Subordinated Lender under the Subordinated Loan Agreement.

"Subordinated Loan Agreement" means the agreement so called executed on 23 November 2000 between CMS7, the Issuer and the Trustee relating to the provision of a loan facility by CMS7 to the Issuer for the purposes listed therein.
