#### **DIRECTORS' REPORT**

The directors present their Annual Report and the audited Financial Statements of Collateralised Mortgage Securities (No 4) PLC ('the Company'), registration no 2173125, for the year ended 30 September 2010

#### **BUSINESS REVIEW AND PRINCIPAL ACTIVITIES**

The Company is a wholly owned subsidiary of The Paragon Group of Companies PLC ('the Group') The Company provided funding for the issue costs incurred by a fellow group company. The principal activity of the Company in the current period was the provision of funds to other group companies. The directors consider that the Company has performed satisfactorily in the current year.

The Company's profit and loss account is shown on page 5 The result after tax has decreased from a profit of £1,000 to a result of £11

The balance sheet on page 6 of the Financial Statements shows that the Company's financial position at the year end, in cash terms, consistent with the prior year. Net assets have decreased due to the payment of the interim dividend during the year. Details of amounts owed from and to other group companies are shown in notes 8 and 11

The directors recommend no final dividend (2009 £nil) which, given the interim dividend of 10 pence per share (2009 £nil), means a total dividend for the year of 10 pence per share (2009 £nil)

The Group manages its operations on a centralised basis. For this reason, the Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business. The performance of the Group's mortgage lending operation, which includes the Company, is discussed in the Group's Annual Report, which does not form part of this Report.

#### PRINCIPAL RISKS AND UNCERTAINTIES

The Company's primary financial assets and liabilities are with other group companies, therefore the directors do not consider that the Company is exposed to any significant cash flow, credit or liquidity risks

After considering the above, the directors have a reasonable expectation that the Company will have adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the Financial Statements.

#### **ENVIRONMENT**

The Group recognises the importance of its environmental responsibilities, monitors its impact on the environment, and designs and implements policies to reduce any damage that might be caused by the Group's activities. The Company operates in accordance with Group policies, which are described in the Group's Annual Report, which does not form part of this Report.
