#### Activities

#### Change of name

On 22 May 1995 Badger Catering Services Limited changed its name to FB Properties Limited. On 16 August 1995 FB Properties Limited changed its name to FirstBus Transit Developments Limited.

## Change of ultimate holding company

With effect from 16 June 1995, Badgerline Group plc and GRT Bus Group PLC merged under FirstBus plc, which became the ultimate holding company of Firstbus Transit Developments Limited.

In order for the accounts of Firstbus Transit Developments Limited to be co-terminous with those of FirstBus plc, the accounting reference date for the company has been changed from 31 December to 31 March and so these accounts have been drawn up for a 15 month period ended 31 March 1996.
