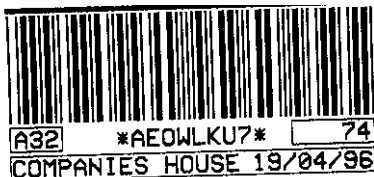

NOTES
