- THAT the articles of association of the Company be amended by the insertion of the following text after paragraph 15

"16. Distributions

# 16.1 Policy

Subject to clause 16 3 it is the intention of the shareholders that the Company (or other member of the Company's group) shall distribute to the shareholders (whether by way of distributions in respect of the shares, payment of interest on Loan Notes, redemption of Loan Notes, upstream loans or otherwise) the maximum amount available for such purposes in any financial year. Accordingly, the shareholders agree that subject to

(a) compliance with the terms of the Finance Agreements, applicable laws and regulations (including but not limited to the Companies Act), and
