## RIDER 7

- (i) First fixed charge over all estates or interests in any freehold or leasehold property now or at any time during the continuance of this security belonging to the Company;
- (ii) First fixed charge over the goodwill and uncalled capital for the time being of the Company and all its patents, patent applications, trade marks, service marks, trade names, registered designs, copyrights, licences and all ancillary and connected rights both present and future;
- (iii) First fixed charge over all securities deposited with the debenture holder pursuant to the terms of the Loan Agreement and all investments of the Company quoted on any recognised stock exchange, both present and future;
- (iv) First fixed charge over the whole of the equity share capital of I.I.G.(UK) Limited (now known as International Hoteliers (UK) Limited) and all stocks, shares and other securities now or at any time during the continuance of this security belonging to the Company in I.I.G.(UK) Limited (now known as International Hoteliers (UK) Limited) and any of its other subsidiary companies together with all future stocks, shares or other securities and all rights, accruing or deriving directly or indirectly from any thereof at any time.
