 the relief sought by this Claim as appears from the waiver letter from the Treasury
 Solicitor dated the 27 August 2015

*And the claimant's counsel informing the court that the claimant has been unable
 to trace any director or officer of the company*

AND upon the Claimant undertaking to inform the Registrar of Companies
 immediately on the conclusion of the Claimant's application to Her Majesty's Land
 Registry for the registration of the Claimant as registered proprietor of the property
 referred in the Transfer to the Claimant dated 20 November 2012 and described as
 all that freehold property known as land on the East Side of Abingdon Road, Didcot,
 registered with HM Land Registry under Title Number ON221693 including the
 removal of the charge from that land as indicated by paragraph 18 of the Witness
 Statement of Nicholas Graham dated 15 June 2015

AND UPON the solicitors for the Claimant and for the Registrar of Companies
 (the Defendant) both consenting to this Order

IT IS ORDERED THAT

(1) the name of the above named Columbus Asset Management
 Limited be restored to the Register of Companies

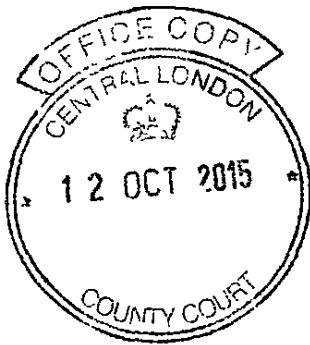
