We are required to provide you with a final account on the conduct and outcome of the liquidation. This final progress account is for the period 22 September 2017 to 8 January 2018.

We are also required to give you certain information about the Company and the Liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

REPORT ON THE LIQUIDATION

Realisation of assets:

The directors' Declaration of Solvency showed that the Company's sole asset was:

Realisations from the Company's assets are as detailed in the above summary and totalled £1.

No additional assets have been identified.

Settlement of liabilities:

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No such claims were received.

HMRC:

After our appointment we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities.

All matters have now been cleared and HMRC have confirmed their agreement to us closing the liquidation.

Distribution to the sole shareholder:

At the time of our appointment the issued share capital of the Company was 1 £1 ordinary share.

During the liquidation we made a first / final distribution in specie of £1 to the sole shareholder. The distribution consisted of the inter-group debtor balance due to the Company from the shareholder together with any other assets held.

OUR FEES AND EXPENSES

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

Our liquidation fees and expenses have been settled by Metsa Board Oyj in connection with the liquidation of the Company and 1 connected company, M-Real UK Holdings Limited (In Liquidation). A third connected entity was placed into liquidation on the same date however our fees and expenses are being met by another group entity. Accordingly our fees reported below are in relation to the liquidation of the Company and M-Real UK Holdings Limited (In Liquidation) only.

Our fees consist of time costs incurred for both the pre and post liquidation periods. Time costs incurred to 29 December 2017, being the latest practicable date for the account, totalled £34,578, representing 81 hours at an average hourly rate of £427. Of this time, £22,175 has been invoiced and I estimate a further £6,000 will be incurred concluding the liquidations.

Invoices raised to date have totalled £22,175 and in order to conclude the liquidations of the Company and M-Real UK Holdings Limited (In Liquidation) we have obtained approval to raise a final invoice for £15,000 plus disbursements.

Liquidators' expenses:

During the liquidation we have incurred Category 1 expenses totalling £470 which relate to the all three liquidations.

1. Category 1 expenses represent specific expenditure incurred directly in respect of this liquidation and payment has been to independent third parties.

This concludes our account.
