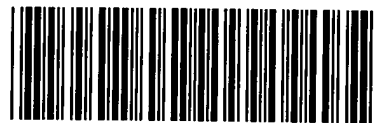



**1. Accounting policies**

*Basis period*

The accounting period is for the 367 day period ending 2 January 2015, comparative figures are for the year ending 31 December 2013. For the purposes of these financial statements the period ended 2 January 2015 is referred to as the 2014 year end.

*Dormant Status*

The company was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 02 January 2015. The company has not traded during the year or during the preceding financial year. During these periods, the company received no income and incurred no expenditure and therefore made neither profit nor loss.
